## Autonomous Driving Level

**PURPOSE:** Automated-driving-system-operated vehicles ("ADS-operated vehicle") may operate without a human driver on Tennessee streets and highways, provided the following conditions are met: (1) the vehicle has been certified by the manufacturer as being in compliance with federal motor vehicle safety standards; (2) the vehicle is capable of achieving a minimal risk condition in the event of an ADS failure; and (3) the vehicle is registered in accordance with Title 55, Chapter 4, and identified on the registration as an ADS-operated vehicle. See Tenn. Code Ann. § 55-30-103. Tenn. Code Ann. § 55-30-108 further provides that all ADS-operated vehicles are "held to the same laws as conventionally operated motor vehicles, including the financial responsibility requirements of § 55-12-102." The registrant's provision of the information below is necessary to identify an ADS-operated vehicle on the certificate of registration.

**Level of Advanced Driving Assistance Systems (ADAS):**

**Level 2 - Partial Driving Automation:** The vehicle can provide steering, brake, and acceleration support to the driver. The driver monitors all operational tasks and can take control at any time.

**Level 3 - Conditional Driving Automation:** The vehicle is equipped with environmental detection capabilities and can perform most driving tasks, but the driver retains override capabilities.

**Level 4 - High Driving Automation:** The vehicle is equipped with environmental detection capabilities and performs all driving tasks under specific circumstances, without the expectation that driver intervention will be necessary.

**Level 5 - Full Driving Automation:** The vehicle is equipped with environmental detection capabilities and is designed to perform all driving tasks under all conditions, without any expectation that driver intervention will be necessary.
