


SUMMARY

The properties consist of four (4) non-contiguous parcels located on the north and south sides of Sam Cooper Boulevard between East Parkway North and North Merton Street, in an urban area of Memphis known as Binghampton. General east-west access to the area is provided by Sam Cooper Boulevard, Broad Street, Summer Avenue, and Poplar Avenue. North-south area access is dominated by Highland Street, Holmes Street, Hollywood Street, and East Parkway. ***The properties are being offered as one single transaction and not individually.***



PROPERTY INFORMATION

The area has a limited supply of undeveloped land as the area was developed more than fifty years ago. New construction is very limited. Existing uses in the immediate area include residential, institutional, industrial, and commercial. Zoning classifications nearby include "R-6" Residential Single-Family – 6, "R-15" Residential Single-Family – 15, "RU-1" Residential Urban – 1, "RU-3" Residential Urban – 3, "Emp" Employment District, "CMU-1" Commercial Mixed Use – 1, and "CMU-3" Commercial Mixed Use – 3.

Zoning - "R-6(H)" Residential Single-Family - 6 with an Historic Overlay District.

Utilities - The area is served by all the usual public utilities including electricity, natural gas, public approved water, and sanitary sewers provided by Memphis Light, Gas and Water. Telephone service is available through AT&T.

Flood Hazards - Flood Hazards Map #47157C0290F, effective September 27, 2007, indicates that the subject parcels are located in an area identified as Zone X (outside the flood hazard boundaries) and are classified as having a "low flood risk."

MARKET AREA OVERVIEW

The subject is located in the 38112 zip code area. According to the ESRI Demographic and Income Profile, the population within this zip code area was 18,391 in 2010, decreasing 0.18% to 18,357 in 2014. By 2019, the population is anticipated to increase to 18,540.

The number of households in 2010 was 7,062, increasing to 7,094 in 2014. During this same time period, the average household size declined from 2.41 persons to 2.39 persons. The number of households is anticipated to increase to 7,199 by 2019, when the average household size is anticipated to be 2.38 persons.

In 2014, the area had 3,004 owner-occupied housing units and 4,090 renter-occupied housing units. By 2019, owner-occupied units are anticipated to increase to 3,073, while renter-occupied units are expected to increase to 4,126.

For 2014, the average household income was \$49,218, while the median household income was \$29,257. By 2019, the average income is anticipated to increase 17.9% to \$58,032, while the median household income is projected at \$35,423.

The State of Tennessee requests sealed bids for the collective purchase all four (4) real estate parcels located on Sam Cooper Boulevard, Memphis, Tennessee commonly known as Parcels #1, #1A, #3 and #5.

BID PROCEDURE

METHOD: Sale is to be by the sealed bid method. The State reserves the right to refuse or reject any or all bids.

OPENING: Sealed bids will be opened *to be determined* at 1:30 p.m. (Central Time) at the State of Tennessee Real Asset Management office in Nashville, Tennessee. Bids must be received by Real Asset Management no later than the opening time and date. Late bids will be returned unopened.

FORMAT: The bid must state the amount of the bid and identify the party or entity to whom the property will be conveyed. Bids must be sealed and contain the following information on the bottom left hand corner of the envelope:

SECURITY DEPOSIT: The bid must include a security deposit by cashier's check, in the amount of five (5%) of the total bid, payable to the State of Tennessee. The security deposit will be forfeited if the successful bidder fails to perform. Security deposits will be returned to unsuccessful bidders by separate State warrants within three weeks.
