All board meetings begin at 9:00 a.m., Central Time. Board meetings are held at the board's office and are open to the public. Dates are subject to change, but are listed on the board's website. In the event of an electronic meeting, a conference room is made available to the public and is the location from which the electronic meeting is conducted.

## BOARD SUBCOMMITTEES

The Board for Licensing Health Care Facilities voted and approved at the February 7, 2013 Board meeting the continued work of the home medical equipment (HME) subcommittee to work on the body of the home medical equipment rules and reconsider the blood glucose interpretative guideline and the development of an assisted care living facility (ACLF) subcommittee to work on the body of the assisted care living facility rules.

The HME subcommittee met on April 25<sup>th</sup>, 2013. The subcommittee voted to rescind the previous Board interpretative guideline concerning blood glucose meters; blood glucose meters are not to be considered diagnostic equipment. The full Board approved the subcommittee's recommendation at the May 1<sup>st</sup>, 2013 meeting. Also, at the May 1<sup>st</sup> meeting, several HME interpretation requests were moved to the subcommittee for consideration. The HME subcommittee met again on June 27<sup>th</sup>, 2013 to address the HME regulations as a whole and interpretation requests, 1200-08-29-.01(19)(b)1 and allowance of subcontracting, presented at the May 1<sup>st</sup>, 2013 Board meeting. The subcommittee considered 1200-08-29-.01(19)(b)1 and voted the regulation requires no further interpretation by a vote of 2 to 1; nursing homes and hospitals are not required to have HME licensure provided they use home medical equipment in the normal course of services provided within each institution. The subcommittee also expressed that the HME regulations contemplate subcontracting based upon 1200-08-29-.06(6)(g)1 & 2. These results are to be presented to the full Board at the September 11<sup>th</sup> & 12<sup>th</sup>, 2013 meeting.

The ACLF subcommittee met on June 6<sup>th</sup>, 2013. Medication disposal language was approved by the subcommittee for presentation to the full Board at the September 11<sup>th</sup> & 12<sup>th</sup>, 2013 Board meeting. The subcommittee further determined fifteen (15) problematic items of the ACLF rules. These problematic items were prioritized by importance and the top three - medication administration, evacuation, and infectious

disease - are to be addressed at the August 30<sup>th</sup>, 2013 ACLF subcommittee meeting.

## EMS REPORT

At the May 1, 2013 Board for Licensing Health Care Facilities meeting, Rob Seesholtz, Trauma Manager with the Office of Emergency Medical Services, informed the Board of the trauma registry rule language becoming effective May 13, 2013. The Board was provided the Trauma Care Advisory Council's meeting minutes and the trauma destination guidelines for review. Mr. Seesholtz also reported that a policy and procedure manual was being worked on for the release of trauma registry data and the data dictionary is nearing completion. Finally, the Board was given an update on trauma center site visits.

## NURSE AIDE REPORT

At the May 1, 2013 Board for Licensing Health Care Facilities meeting, Wanda King, Nurse Aide Program Manager with the Office of Health Care Facilities, presented to the Board a listing of licensed nursing homes providing nurse aide training which have had poor performance in testing over the last three (3) years. She requested of the Board their desire for action. The Board voted to have legal counsel and staff to develop rule language to address nurse aide training programs. The Board also approved by vote to have the Office of Healthcare Facilities submit notification to the poor performing facilities, to have the poor performing facilities submit a plan of correction (POC), and to explain and present this POC to the Board at the next Board meeting.

## STATUTORY CHANGES OF INTEREST TO TENNESSEE HEALTH CARE FACILITIES

The 2013 Legislative Session has ended and the Board for Licensing Health Care Facilities' administrative staff has monitored several bills that are of interest to the licensed health care facilities in the state of Tennessee. Below is a brief summary of those bills. ### PUBLIC CHAPTER NO. [0004](#)

This public chapter as enacted amends TCA 68-11 by adding the option for a hospital to file a notarized statement indicating certain data when a change of ownership occurs in lieu of filing a joint annual report with the Department of Health. Effective 3/7/13.

### PUBLIC CHAPTER NO. [0060](#)

This public chapter as enacted amends TCA 68-5-1 by requiring hospitals to give patients, upon discharge, certain information concerning influenza and vaccines. Effective 7/1/13.

### PUBLIC CHAPTER NO. [0089](#)

This public chapter as enacted amends TCA 68-11-201, 68-11-203, 68-142-103, and 71-5-137 by revising the membership of the child fatality prevention team and requires conflict of interest disclosures for certain persons associated with an MCO that participate in the TennCare be made to "the bureau of TennCare," instead of "the commissioner of health"; and removes some code references to the public health council terminated in 2008. Effective 7/1/13.

### PUBLIC CHAPTER NO. [0113](#)

This public chapter as enacted amends TCA 68-11 by requiring mammography records to be retained for 10 years following the patient's discharge from a hospital or death and authorizes the board of medical examiners to promulgate rules and regulation in retaining medical records. Effective 4/12/13.

### **PUBLIC CHAPTER NO. [0197](#)**

This public chapter as enacted amends Title 68 by requiring hospitals, birthing centers, and health care facilities which provide medical care to newborns as well as obstetricians who provide routine care for prenatal patients must make available information and instruction concerning the appropriate use and techniques of infant cardiopulmonary resuscitation (CPR) to at least one parent or caregiver of a newborn infant. Effective 7/1/13.

### **PUBLIC CHAPTER NO. [0234](#)**

This public chapter as enacted amends TCA 68-11-1628 by permitting the relocation under certificate of need statute of up to 30 beds from an existing nursing home that is part of a continuing care retirement community under certain conditions. Effective 7/1/13.

### **PUBLIC CHAPTER NO. [0238](#)**

This public chapter as enacted amends Title 68 by authorizing surrogates under the Tennessee Health Care Decisions Act to seek voluntary admission to inpatient mental health treatment for certain patients. Effective 7/1/13.

### **PUBLIC CHAPTER NO. [0254](#)**

This public chapter as enacted amends TCA 68-11 by replacing the current universal do not resuscitate order statute with a new provision authorizing physician orders for scope of treatment (POST). Effective 4/19/13 for rulemaking; 7/1/13 for remainder.

### **PUBLIC CHAPTER NO. [0266](#)**

This public chapter as enacted amends TCA 63-10 by revising the definitions of "compounding" and "dispense" in the Pharmacy Practice Act and exempts hospital pharmacies compounding for inpatients of a hospital from the requirement that sterile compounding pharmacies quarterly report the quantity of sterile compounded products dispensed. Effective 4/25/13.

### **PUBLIC CHAPTER NO. [0311](#)**

This public chapter as enacted amends Title 68 by extending the current moratorium on the issuance of certificates of need (CONs) for new nursing home beds until June 30, 2014. Effective 7/1/13.

### **PUBLIC CHAPTER NO. [0356](#)**

This public chapter as enacted amends Title 68 by extending for one year the nursing home privilege tax and renames such tax the nursing home annual assessment fee. Effective 7/1/13.

### **PUBLIC CHAPTER NO. [0387](#)**

This public chapter as enacted amends Title 63 by requiring facilities and physicians to communicate certain information about mammographic breast density to patients. Effective 1/1/14.

### **PUBLIC CHAPTER NO. [0391](#)**

This public chapter as enacted amends TCA 68-57-1 by specifying that persons employed as surgical technologists earn 60 continuing education credits to meet national certification established by the National Board of Surgical Technology and Surgical Assisting (NBSTSA). Effective 7/1/13.

### **PUBLIC CHAPTER NO. [0410](#)**

This public chapter as enacted amends TCA 68-11 by authorizing a special alternative payment plan for certain nursing homes that are delinquent in payments of the annual nursing home tax. Effective 5/16/13.

### **PUBLIC CHAPTER NO. [0431](#)**

This public chapter as enacted will be called "Lynn's Law" and amends TCA 39-15-1 and 71-6-1 by defining abuse or neglect of an adult to include transporting an adult and knowingly abandoning, leaving or failing to provide additional planned transportation for the adult in certain situations.
