Minutes

Office of General Counsel

Mr. Mullins presented the following OGC report:

A. Litigation

There are no orders to be presented for ratification.

B. Legislation

SB 1528/HB 1605 (P. Ch. No. 603) – As introduced, extends board of occupational therapy until June 30, 2019. It also reconstitutes the manner by which OT and OTA members are nominated to the Board. The governor SHALL nominate members from lists submitted by interested groups including the TOTA.

C. Rules

There are no pending rules at this time.

Agreed Citations

Investigation and Disciplinary Reports

There were four (4) open OT complaints and no open OTA pending complaint in Investigations as of July 10, 2014. There were two (2) OTs and two (2) OTAs currently being monitored following Board disciplinary actions during this period.

TnPAP Report

Mr. Michael Harkreader, Executive Director, TnPAP, presented the report for the period of July 1, 2013 through June 30, 2014. There was one (1) OT being monitored and there were no OT referrals.

Correspondence

- A. Modality Sign-off – The Board discussed correspondence from **Ciat Rocco** regarding Modality sign-off on OT students, specifically if a supervising OT outside of the State of Tennessee and/or any PT within or outside the State of Tennessee can sign off on a student’s modality hours in order to be certified to practice Electrical and Thermal modalities. The Board confirmed rule 1150-02-.04 (4) and (5), which states the qualification for getting certified for Physical Agent Modalities and also provides proof that any OT that is currently certified and any PT can sign off on a student’s clinical and didactic hours.
- B. Non-custom diabetic shoes and inserts – The Board discussed correspondence from **Micah Grace** regarding OTs and/or OTAs providing non-custom diabetic shoes and inserts. The Board members have deferred discussion until the next Board meeting after more information is provided.

Legislation

SB1629/HB1425 – As enacted, authorizes online applications for various occupations regulated by the division of health related boards; revises public record status of certain investigatory records of the department of health.

SB2050/HB1895 – As enacted, requires that a health insurance carrier provide coverage under a health insurance policy for healthcare services delivered through telehealth in certain circumstances. The bill became Public Chapter 675 and goes into effect January 1, 2015.

Administrative Report

As of July 8, 2014, there are 2349 active OT’s and 1257 active OTA’s.

Licensure status totals since the last board meeting for the months of March 2014 through July 8, 2014 are as follows:
