



Approved Software Means Improved Processing for Tennessee Taxpayers

Paper tax returns that are scannable can be processed more easily and at a lower cost than returns that are not scannable. Below is a list of approved developers who have worked with the Tennessee Department of Revenue for the 2014-2015 filing period to produce versions of returns that are easier and less costly to process.

There are two levels of scannable forms from software developers who reproduce Tennessee returns – returns with a scanline and those who also utilize 2-D barcodes. Please note that Tennessee is working with willing developers to produce 2-D barcode versions of the Tennessee Income Tax (INC 250).

The 2-D technology allows a return's information to be captured with fewer errors, quicker, and with even less expense to process. The barcode itself is not readable except by programmed scanning equipment, but is another vital step to improve the Department of Revenue's ability to do its work more efficiently. The companies participating in either 2-D program will be listed in red.

This list will be updated at least weekly throughout the approval process period. Approvals on some returns types normally begin in October and continue to be added into January.
