(For individuals who are graduates of an EAC/ABET accredited undergraduate engineering curriculum of four (4) years or more or one that has been determined to be substantially equivalent)

You may fill out the application online. The application must then be printed because it must be signed by the applicant and the applicant's sponsor/reference.

Residency Requirements

An applicant for registration by exam must meet Tennessee's residency requirement ([Rule 0120-1-.03](#)).

Fees

Cost of exam – **\$50**

Make checks payable to the **Tennessee Department of Commerce and Insurance**. Payment must be made at the time of application and the fee is not refundable. Submit the completed application and fee to the address on the application form.

Exam Locations

Exams are currently given in Memphis, Martin, Cookeville, Chattanooga, Knoxville, and the Nashville area; however, this is subject to change.

Afternoon Exam Modules

Beginning with the October 2010 exam administration, all candidates must declare which afternoon module they wish to take at the time of application. The following modules are available: Chemical, Civil, Electrical, Environmental, Industrial, Mechanical, and Other/General Engineering.

Forms

(1) Application Form —

- ◆ Type or write your name in #1 on the application as you want it to appear on your certificate and in your permanent record.
- ◆ In # 10 provide an emergency contact to be called in the event of a medical emergency at the exam site.
- ◆ Fill out the application completely online or after downloading it. Sign the application and obtain the required signature from a sponsor/reference. An employer, company official, or former professor must sign your application as a sponsor or reference. Relatives or Board members are prohibited from serving as references.
- ◆ Submit the application and fee (payable to the **Tennessee Department of Commerce and Insurance**) to the Tennessee Board. The application must be received by the stated deadline. Any major modification of state approved forms may cause the Board to reject your application.

(2) Request-For-Transcript Form —

Submit the Registrar's letter to each post-high school institution attended. Your transcript(s) should be submitted directly to the Board office from each institution attended.

Applicants with Foreign Degrees

Rule 0120-1-.10 states that engineering degrees that are not accredited by the Accreditation Board for Engineering and Technology (ABET) shall be referred at the applicant's expense to a person or an entity approved by the Board and qualified to evaluate equivalency to an ABET-accredited engineering program for evaluation and recommendation. The Board has approved the Center for Professional Engineering Education Services (CPEES), an affiliate of the National Council of Examiners for Engineering and Surveying (NCEES),

Applicants with Non-Accredited Domestic Degrees

Rule 0120-1-.10 states that engineering degrees that are not accredited by the Accreditation Board for Engineering and Technology (ABET) shall be referred at the applicant's expense to a person or an entity approved by the Board and qualified to evaluate equivalency to an ABET-accredited engineering program for evaluation and recommendation. The Board has approved a former engineering professor to evaluate domestic undergraduate engineering degrees. The cost for such evaluations is \$40 per hour; an invoice for this service will be sent to applicants requiring an evaluation following receipt of the evaluation.

Scheduling Information

- The Board has contracted with the National Council of Examiners for Engineering and Surveying, (NCEES), for exam administration services, including the scheduling of candidates. Following approval by the Tennessee Board to sit for the exam, candidates must register with NCEES to reserve a seat for the exam. NCEES will distribute test admission notices to approved candidates 2-3 weeks before the exam. For further information, visit the [NCEES website](http://www.ncees.org).***
- Correspondence will be mailed to your designated address. Include your zip code and apartment number if applicable.
- Notify the Board office immediately of any change of address.
- If you must postpone, contact the Board office as soon as possible prior to the scheduled exam date. A \$25 fee will be assessed if you postpone after the exams are ordered.
