1) Call to Order

4) Staff Updates

Lynette Porter, Deputy Director, shared a brief update on federal and state budget items. Congress has not approved the federal FY24 budget but has passed several continuing resolutions which funds Councils through February 2024. The Council will present its state budget to the Tennessee House Finance, Ways, and Means Committee in the coming weeks.

Lauren Pearcy, Executive Director, shared information regarding Council staff. In the fall the Council posted its open position without success in finding the right fit for the position and team. The Council has paused on hiring a new staff member until all staff are back at full capacity.

Council staff are working on information for upcoming Council member vacancies. Two standing committee chairs are part of the seats that will have new members appointed. The Council Chair will begin considering who from the current membership to serve in leadership roles beginning in the next fiscal year.

Members will receive an evaluation tool for rating the Executive Director. The Department of Human Resources will take lead on distributing and receiving the survey responses and will share with the Council Chair for further analysis. This will maintain confidentiality with individual survey responses.

The Joint Needs Assessment project, funded by the Council through Vanderbilt University, is continuing. The Vanderbilt research team has received feedback from multiple groups and has begun making edits to the draft.

5) Other Business

• Disability Day on the Hill is scheduled for February 27-28, 2024. The Council is able to reimburse members who are available and would like to attend the events in Nashville.
