In the event that a student resides with his/her parent(s)/guardian(s) in the home of another person, the following information must be provided to the authorized charter school at registration (All three (3) items MUST be provided):

#### 1. Affidavit of Shared Residency

Signed by the student's parent(s)/guardian(s) and the homeowner

#### 2. Homeowner Proof of Residency

- The homeowner of the home in which the student resides <u>must accompany the</u> <u>parent/guardian to registration</u> and provide at least two (2) of the items listed below bearing the address at which the student will be residing:
  - Driver's license or other state/government issued ID
  - Most recent power, water, or gas bill
  - Mortgage statement or deed
  - Signed lease or rental agreement
  - Real Estate tax receipt
  - Other documentation deemed appropriate by the Commission in the event that two (2) of the items listed above cannot be provided

#### 3. Parent/Guardian Proof of Residency

- The parent/guardian must provide <u>at least two (2)</u> of the items listed below bearing the address at which the student will be residing:
  - Driver's license or other state/government issued ID
  - Car Registration
  - Voter Registration
  - Payroll Stub
  - Three (3) significant pieces of mail
  - Government Assistance Communication
  - Other documentation deemed appropriate by the Commission in the event that two (2) of the items listed above cannot be provided.

**Note:** These requirements <u>do not</u> apply to homeless students. Please contact the school to see if your student qualifies as homeless.

## **Affidavit of Shared Residency**

This affidavit must be re-submitted to the school annually. NOTE: These requirements do not apply to homeless students.
