The following description of foster parent categories will be used to determine minimum training requirements for each foster parent.

Non-Therapeutic Foster Parents (DCS Parents)	Therapeutic Foster Parents
8 Hours Annually	14 Hours Annually

### Required Courses

Some courses are required of all foster parents, while others are required only of foster parents meeting certain placement requirements.

Creating Normalcy through Prudent Parenting	3 Hours	First Year
Preventing Suicide among Foster Care Youth (Jason Foundation) All existing parents are required to complete this requirement September 30, 2024.	3 Hours	First Year
Trafficking Course	2 Hours	First Year
Trauma Course -See Approved Trauma/Therapeutic Page for more information.	Varies	Annually
CPR/First Aid	6 Hours Minimum	Every other year
Medical Resources and Information Refresher	2.5 Hours	Every other year

All foster parents are required to complete one course from this list annually to meet the Trauma requirement.

All therapeutic foster homes are required to receive an additional 6 hours of trauma/therapeutic training annually for a total of 14 hours. Agencies can submit curriculum not included below to the DCS Office of Training and Professional Development for review and approval.
