Public comments will be received concerning the proposed permit action described below:

Tennessee proposes to issue an Individual NPDES Permit to TVA - Watts Bar Nuclear Plant, Permit Number TN0020168, for activities located at Spring City, Rhea County, Tennessee. This permit is to authorize discharge of process wastewater, cooling water and storm water runoff from Outfalls 101 and 102, turbine building sump water, alum sludge supernatant, reverse osmosis reject water, drum dewatering water, water purification plant water, and storm water runoff from Outfall 112 and Supplemental Condenser Cooling Water (noncontact) from Outfall 113.

The hearing officer may limit the length of oral presentation in order to allow parties an opportunity to speak, and will require that all testimony be relevant to water quality issues. Written testimony will be accepted at the hearing, for ten working days following the hearing, and will be considered part of the hearing record.
