ORDER ADOPTING EXAMINATION REPORT

Pursuant to Tenn. Code Ann. §§ 56-1-401, *et seq.*, the Insurance Division of the State of Tennessee Department of Commerce and Insurance (“Division”) has examined certain affairs of American General Property Insurance Company (“Company”), a property and casualty insurance company domiciled in the state of Tennessee. As a result of an examination conducted as of the 31<sup>st</sup> day of December, 2011, the insurance examiner filed with the Division, on the 15<sup>th</sup> day of March, 2013, a verified written report on the examination, and a copy of that report has been sent to the Company. (The Report on Examination of American General Property Insurance Company is attached hereto and marked as Exhibit A.) The Company waived any right to rebuttal with respect to the examination report, pursuant to Tenn. Code Ann. § 56-1-411(d)(1). (The letter waiving rebuttal is attached hereto and marked as Exhibit B.)




this Order Adopting Examination Report merely to adopt the examination report filed by the examiner-in-charge.
