FINAL ORDER OF DISMISSAL WITH PREJUDICE

The Parties, as evidenced by the signatures of their attorneys below, hereby announce to the Court that they have resolved all claims in the above-captioned matter that either party has or may have against the other, and which arise out of or derive from, a dispute between the Parties over the correct amount of total insurance premiums owed by the Insured, RT Construction Company, LLC ("RT Construction"), to Travelers Property Casualty Company of America ("Travelers"), for insurance coverage provided to RT Construction by Travelers under Policy No. 7PJUB-9911M40-8-09 during the policy period of September 13, 2009 to September 13, 2010.

The Parties hereby further announce to the Court their mutual agreement that Travelers' specific claim and demand that RT Construction be required to pay an increased premium amount for the insurance coverage provided by Travelers during the policy period stated herein has been resolved fully, and that the concurrent and related claims of RT Construction disputing the validity and amount of the increased premiums assessed by Travelers for the coverage it provided during the policy period at issue, and which constituted the basis of the Appeal of RT Construction, have also been resolved fully. Further, the Parties mutually agree they do not require or desire this litigation to continue, and accordingly, the Parties hereby request that the Court permit, based upon the Parties announced mutual agreements and resolutions stated herein, dismissal of this litigation with prejudice.

Upon consideration of the mutual agreements between, and the specific announcements by, the Parties, through their attorneys of record, the Court hereby APPROVES the agreement and resolution of the Parties as stated herein in all respects. It is, therefore,

ORDERED and DECREED as follows:

1. The appeal lodged by RT Construction, against the Insurer, Travelers, in this matter shall be, and the same hereby is, **DISMISSED**, in its entirety and with full prejudice;
2. Costs of the appeal are taxed to RT Construction for which execution may issue if necessary;
3. All claims and demands of Travelers against RT Construction for payment of an increased premium amount under Policy No. 7PJUB-9911M40-8-09 which Travelers contends accrued during the policy period of September 13, 2009 to September 13, 2010, and which Travelers contends is owed by RT Construction are dismissed and extinguished; and
4. All concurrent claims and demands of RT Construction against Travelers arising or deriving from the disputed increased premium assessed by Travelers against RT Construction under Policy No. 7PJUB-9911M40-8-09 during the policy period of September 13, 2009 to September 13, 2010 are likewise dismissed and extinguished.






