

Dear Jim:

The Gurley Surgery Center, CNO408-074, was approved at the November 2004 meeting of the HSDA. The Certificate of Need (copy attached) was issued for the establishment of a single specialty ambulatory surgical treatment center (ASTC) for gynecological procedures performed by Larry D. Gurley, M.D. It was limited to gynecological procedures performed by Larry D. Gurley. Dr. Gurley recently affiliated with ADI so that he no longer practices independently but is employed by ADI. He continues to own and perform surgeries at the ASTC. Dr. Gurley would like to be able to allow other gynecologists who may or may not also be employed by ADI to use this surgery center to perform gynecological procedures on their patients. Because of the limitation on the CON, even if Dr. Gurley changes the ownership of the ASTC, other gynecologists still cannot use the ASTC. The ASTC has the capacity to allow other gynecologists to perform surgeries on their patients and the elimination of the condition limiting the use of the surgery center to Dr. Gurley would allow a more efficient use of an existing health care resource.

Dr. Gurley would like this request placed on the General Counsel's report for the August meeting of the HSDA. Both Dr. Gurley and I will be in attendance to present this request and to answer any questions you might have. 
