3 MS. FLYNN: My name is Jennifer Flynn. 18:19:51

4 I'm with the TDOT Community Relations Division from 18:19:53

5 Chattanooga. I want to thank everyone for coming 18:19:57

6 out tonight. I especially want to thank 18:20:00

7 Representative Kelly Keisling and Fentress County 18:20:00

8 Executive Michael Cross and Mark Dudney from the 18:20:03

9 Development District for coming out tonight. 18:20:06

10 What we're going to do tonight is talk 18:20:11

11 about a project on US 127 from State Route 62 at 18:20:11

12 Clarkrange to near Little Road. 18:20:15

13 Our procedure tonight will have a short 18:20:20

14 PowerPoint, and then we'll have a question and 18:20:20

15 answer. If you want to get your questions and 18:20:23

16 comments on the record, the court reporter will be 18:20:25

17 recording everything. After that, you can just mill 18:20:28

18 around and look at plans and talk to people 18:20:31

19 one-on-one. There's a lot of us here. We may 18:20:34

20 outnumber you guys, actually; so you shouldn't have 18:20:37

21 trouble getting help and answers tonight. 18:20:41

22 Sammie McCoy from Benesch, he's going to 18:20:44

23 be doing the PowerPoint. Scott Medlin, Chester 18:20:45

24 Sutherland of our Project Management and Fred Miller 18:20:48

25 from our Design office will be helping answer 18:20:53

1 questions when the question and answer period comes 18:20:57

2 up. 18:20:59

3 So I'm going to turn it over to Sammie 18:21:00

4 for a short PowerPoint presentation so he can let 18:21:02

5 you know why we're here. 18:21:03

6 Thank you. 18:21:05

7 MR. McCOY: I will try to speak so 18:21:07

8 everybody can hear me. I'll use a microphone, but 18:21:13

9 you probably could hear me. 18:21:16

10 Yes. We're here for State Route 28 from 18:21:17

11 State Route 62 to just north of Little Road. This 18:21:20

12 is the commercial district, basically, of 18:21:24

13 Clarkrange. 18:21:27

14 I'm glad everybody made it out tonight 18:21:28

15 and hopefully you'll leave with some good 18:21:31

16 information. 18:21:34

17 This was up earlier. After questions 18:21:35

18 and answers, we'll hopefully end the meeting around 18:21:39

19 7:00 at the latest. That's kind of our agenda for 18:21:42

20 tonight. 18:21:47

21 The map here gives us an idea. It is 18:21:48

22 just a seven-tenths of a mile project starting just 18:21:51

23 south of the intersection of State Route 62 and 18:21:55

24 continuing just north of Little Road. 18:21:58

25 Now your first question may be: "Well, 18:22:00

1 why are you starting south of the intersection?" 18:22:01
2 There is a project to the south which has been out 18:22:03
3 for right-of-way acquisition for the last couple of 18:22:07
4 years. All we are doing is tying this seven-tenths 18:22:10
5 of a mile project through the commercial area of 18:22:15
6 Clarkrange onto that southern project so that all of 18:22:17
7 these improvements to the 62 intersection, as well 18:22:21
8 as the commercial areas of Clarkrange, all that work 18:22:24
9 is done at one time versus being spread out over 18:22:28
10 several years. 18:22:33

11 So the project purpose and need is to 18:22:33
12 improve the operational efficiency along State Route 18:22:36
13 28 to accommodate future traffic growth in the area; 18:22:41
14 improve roadway safety on State Road 28, which is 18:22:44
15 also US 127; improve safety and accessibility for 18:22:49
16 pedestrians; and improve transportation 18:22:54
17 infrastructure to support community growth and 18:22:56
18 economic development. That's the project purpose in 18:22:57
19 a nutshell. 18:23:06

20 The meeting purpose is to inform the 18:23:07
21 public about the design and performance with the 18:23:09
22 community's plan for future development, provide 18:23:11
23 plans for public review, gain insight about the 18:23:13
24 public's thoughts and concerns. We want your 18:23:17
25 feedback tonight. 18:23:20

1 That brings us to the next point. We 18:23:23
2 need your input tonight. If you have a good 18:23:28
3 comment, we'll take good comments. If you have a 18:23:30
4 bad comment and you want to talk about something, 18:23:33
5 you can talk to me or anybody else out here looking 18:23:36
6 at the drawings, but we're not necessarily going to 18:23:39
7 officially report it. The only way it officially 18:23:43
8 gets recorded is if it's written on this comment 18:23:44
9 card and turned in tonight, written on the comment 18:23:46
10 card and mailed in, or you can talk to the court 18:23:50
11 reporter. Those three methods get you officially on 18:23:52
12 the transcript so that we officially know your 18:23:56
13 concern because I may talk to 30 people tonight and 18:23:59
14 forget that I have one driveway that I need to 18:24:03
15 address. 18:24:06
16 As far as mailing in comments, you can 18:24:09
17 do that by e-mail. You'll see e-mails here in a 18:24:11
18 minute. You've got to do that in the next 21 days. 18:24:14
19 So here we are in the project 18:24:20
20 development process. Starts out with a local 18:24:23
21 request. It moves into the planning phase. Then in 18:24:25
22 the design phase starts, which is the beginning of 18:24:29
23 when I got involved with the project, in the design 18:24:32
24 phase, and now we're here at the public hearing and 18:24:34
25 meeting. So we're looking at preliminary plans. 18:24:38

1 TDOT produces preliminary plans, comes and meets 18:24:41
2 with the public, they produce right-of-way plans, 18:24:45
3 that is when they come out and acquire the property, 18:24:49
4 and then they produce the construction documents 18:24:52
5 that the contractors bid on. That's the three 18:24:54
6 phases of the project. 18:24:57
7 We're in this initial phase of the 18:24:57
8 preliminary; so if there are issues that arise 18:24:59
9 tonight, it can move back up and we can relook at 18:25:03
10 things; so we want your input today. 18:25:06
11 Once it moves to the next phase, the 18:25:10
12 right-of-way phase, then things start getting more 18:25:12
13 tied down. Just keep that in mind that we're 18:25:15
14 working tonight to get some good input. 18:25:18
15 Project history. The initial advanced 18:25:22
16 planning report was completed in 2007. The 18:25:22
17 preliminary plans development began in the fall of 18:25:26
18 '13; so our work began in the fall of '13. 18:25:30
19 The improvements that we're going to 18:25:35
20 have on project, State Route 28 is going to be a 18:25:37
21 five-lane section. You're going to have a center 18:25:41
22 turn lane so you can turn left into business. 18:25:44
23 You're going to have two northbound lanes, two 18:25:48
24 southbound lanes. That's your five-lane section. 18:25:52
25 Then, on the outside, you will have a four-foot bike 18:25:54

1 path, which also can be used as a shoulder. Then 18:25:57
2 you'll have curb and gutter and sidewalks down both 18:25:59
3 sides of the roadway. 18:26:02
4 In several locations around the room are 18:26:07
5 the same layout. The purpose is so that you've got 18:26:10
6 something to look at and talk about and tell what's 18:26:15
7 taking place. If you want to see more details, 18:26:17
8 there's a set of engineering documents that are 18:26:20
9 drawn at a different scale. They're easier to read 18:26:24
10 for us engineers and we can explain it to you. 18:26:27
11 We'll be glad to look at that and go through that. 18:26:31
12 The nice color layout shows the aerial photography 18:26:31
13 below so you get an idea of what's taking place. 18:26:36
14 I want to point out two things. There's 18:26:39
15 colors related to the acquisition of each property 18:26:40
16 and there's tract numbers. The tract number takes 18:26:43
17 you to the next phase and -- the tract number is a 18:26:47
18 number; so if you find your name or your piece of 18:26:56
19 property, it's going to have a tract number, which 18:27:00
20 is in the first column. The second column is the 18:27:02
21 property owner's name. Then it goes to deed book, 18:27:05
22 page number, that kind of stuff. It talks about the 18:27:08
23 area that you currently own for the total tract. It 18:27:11
24 talks about the area that the State wants to 18:27:14
25 purchase or will need to purchase. It talks about 18:27:17

1 easement areas. Then it will tell you how much area 18:27:19
2 is remaining once the project is done. All of that 18:27:23
3 information is on this little sheet. They should be 18:27:27
4 laying around, as well. But you can find that with 18:27:29
5 the property name and the tract number. There's a 18:27:32
6 circle around the number, basically. 18:27:36
7 Two things -- or one thing to keep in 18:27:38
8 mind. This survey is fairly up to date. It's 18:27:40
9 probably six months old as far as any acquisitions 18:27:45
10 or property owner changes. If you look and you say, 18:27:49
11 "I own that piece of property. I just bought it 18:27:51
12 three months ago", we probably don't know that yet. 18:27:54
13 We need to know that, and that's fine. That can be 18:27:58
14 a comment that you can make that Tract Number 157 18:28:00
15 has changed owners. Just keep that in mind. It's 18:28:03
16 as up to date as probably six months ago. 18:28:07
17 A little information and some of that is 18:28:13
18 contained in the handouts that were given out 18:28:14
19 tonight. If you want to know more about the 18:28:17
20 right-of-way information, you can contact the Region 18:28:20
21 2 office in Chattanooga. If you want to know more 18:28:23
22 about utility information, you can contact their 18:28:27
23 number in Chattanooga, as well. If you want more on 18:28:31
24 the survey, you can contact them, as well. That 18:28:35
25 gives you three points of contact down in 18:28:37

1 Chattanooga to talk with TDOT folks, which most of 18:28:39

2 them are here tonight. 18:28:43

3 Last but not least, Jennifer just 18:28:45

4 mentioned a minute ago Mr. Fred Miller is here. 18:28:49

5 He's the Assistant Director of Design and he is here 18:28:52

6 representing the Design Division. Here is his 18:28:56

7 contact information, as well as Scott Medlin, who is 18:28:59

8 the Project Manager for the project, and that is his 18:29:02

9 contact information. 18:29:06

10 That is very briefly a quick rundown of 18:29:07

11 why we're here tonight, the purpose in the project, 18:29:13

12 and, at this point, we'll turn it over to questions 18:29:17

13 and answers. 18:29:22

14 Do you-all have anything else to add 18:29:23

15 first, Scott or Chester? 18:29:25

16 Okay. 18:29:28

17 MS. FLYNN: If anybody does have a 18:29:31

18 question that they want to ask or a comment that 18:29:32

19 they want to make, I would ask that you please state 18:29:35

20 your name for the court reporter so that will get 18:29:38

21 into the transcript. That's another way that it 18:29:40

22 will also get into the official transcript is if you 18:29:44

23 want to speak out at this question and answer 18:29:45

24 session. 18:29:48

25 Does anybody have any questions or 18:29:49

1 comments? Anybody? 18:29:51

2 MS. TREADWELL: I'm Karen. I just want 18:29:53

3 to know if you can go back to the previous page with 18:29:55

4 the phone numbers. 18:29:58

5 MS. FLYNN: We can do that, the previous 18:30:00

6 page with the phone numbers. 18:30:02

7 Okay. That was easy. 18:30:04

8 MR. JONES: I'm Mike Jones. 18:30:08

9 MS. FLYNN: Okay. 18:30:09

10 MR. JONES: Do you need my address or -- 18:30:11

11 MS. FLYNN: As long as you signed in, 18:30:14

12 your name will be just fine. 18:30:15

13 MR. JONES: What is the timeline for 18:30:18

14 construction on this and is it set for the five 18:30:19

15 lanes and sidewalks and bicycle right-of-way or 18:30:23

16 whatever? Is that -- is that a set deal or -- 18:30:28

17 MR. MEDLIN: In terms of the time frame, 18:30:33

18 we're hoping to get into the right-of-way phase of 18:30:34

19 this project, finish the right-of-way plans and move 18:30:38

20 into the right-of-way phase late this year, late 18:30:41

21 2015. We hope to actually move into the 18:30:43

22 right-of-way phase and appraisal part of the 18:30:45

23 right-of-way phase in early '16. 18:30:48

24 We will have another meeting with all 18:30:51

25 the property owners that are affected by the project 18:30:53

1 sometime next year and probably have it here at the 18:30:57

2 same school facility. We have 36 tracts, I believe, 18:31:01

3 to acquire on this project, and it will take us 18:31:05

4 about a year-and-a-half or so to get through that 18:31:08

5 process of getting through the appraisals, appraisal 18:31:11

6 review, and acquisition on that. 18:31:14

7 In terms of construction, when that time 18:31:16

8 frame is, the construction time frame is really 18:31:19

9 funding dependent. I don't know if you've seen in 18:31:23

10 the news or read in the newspaper about the funding 18:31:25

11 situation with the federal transportation budget. 18:31:28

12 Congress, the United States Congress, needs to pass 18:31:32

13 a multi-year transportation bill with highway 18:31:35

14 funding in it for us to move into the construction 18:31:40

15 phase. 18:31:43

16 If we get all the way through the 18:31:44

17 right-of-way phase and get all of our permits and 18:31:46

18 get all the right-of-way acquired for the property, 18:31:49

19 it will probably be sometime in early 2018 before we 18:31:52

20 can actually move into the right-of-way phase if we 18:31:57

21 have federal funding and if this section is budgeted 18:31:59

22 for construction. 18:32:02

23 MR. McCOY: Did you mean construction 18:32:05

24 phase? 18:32:05

25 MR. MEDLIN: Yeah, 2018. 18:32:05

1 MS. FLYNN: You said for right-of-way 18:32:06

2 2018. 18:32:08

3 MR. MEDLIN: Construction in 2018, I'm 18:32:10

4 sorry. 18:32:12

5 MR. McCOY: Then he also asked about the 18:32:13

6 five lanes and -- 18:32:13

7 MR. MEDLIN: Yes. 18:32:16

8 This is the option that is being 18:32:17

9 considered for this section here. We're looking at 18:32:19

10 a build or no build-type solution for this section. 18:32:23

11 Five lanes, curb and gutter with sidewalks and a 18:32:28

12 four-foot bike path or a paved shoulder there is the 18:32:32

13 option there; so we're either looking at a build or 18:32:35

14 a no build. 18:32:39

15 This project, by the way, is still in 18:32:40

16 the environmental phase, as well. We haven't 18:32:41

17 completed the environmental document on the project 18:32:44

18 yet. It is under way and should be finished a 18:32:48

19 little bit later this year in time for the 18:32:50

20 right-of-way plans and we are looking for your 18:32:52

21 comments on any environmental features. 18:32:55

22 MR. JONES: I know at the four-way down 18:32:58

23 here they have a well. I don't know how you're 18:33:00

24 going to deal with that. 18:33:04

25 MR. MEDLIN: Yes, sir. We try to avoid 18:33:05

1 and minimize -- avoid if we can, and if we can't 18:33:07
2 avoid wetland features like that, we try to minimize 18:33:10
3 our impacts to those areas. Then what impacts we do 18:33:15
4 have on the wetlands, we have to mitigate those with 18:33:19
5 the Tennessee Department of Environment and 18:33:24
6 Conservation and the US Army Corp of Engineers. We 18:33:27
7 have to get permits and provide for mitigation areas 18:33:28
8 for those. 18:33:30

9 MR. JONES: You will meet again with the 18:33:32
10 folks that you're taking their property? How do you 18:33:35
11 negotiate a price for that? 18:33:39

12 MR. MEDLIN: We hire independent 18:33:42
13 appraisers that go evaluate the property. We'll 18:33:45
14 contact the property owner, make an appointment with 18:33:48
15 them, go through the property with them, and the 18:33:52
16 appraiser will do a complete, full appraisal on 18:33:54
17 that. He'll turn that into our office in 18:33:58
18 Chattanooga, which we'll review the appraisals and 18:34:01
19 compare those with comparable sales in the area. 18:34:06
20 Once they determine a price on that, they'll come 18:34:09
21 and make an offer to the property owner. 18:34:12

22 MS. FLYNN: Do you want one of these 18:34:17
23 brochures? They had those out -- 18:34:19

24 MR. SUTHERLAND: Scott, we have 18:34:21
25 right-of-way personnel here, even an appraiser or 18:34:22

1 two that can give detailed information. 18:34:25

2 MS. FLYNN: Yes. 18:34:26

3 MR. MEDLIN: We have two of our 18:34:27

4 appraisers here on the back wall. 18:34:28

5 Frank, if you want to hold up your hand. 18:34:29

6 And, Brett. 18:34:31

7 Those two gentlemen are from our 18:34:31

8 Appraisal section in Chattanooga and they'll be glad 18:34:33

9 to answer any questions regarding appraisals that 18:34:36

10 you might have. 18:34:39

11 Most of the folks on the back row in 18:34:40

12 this area here are from our right-of-way office, 18:34:42

13 too; so they have additional information that I 18:34:45

14 don't have personally about our right-of-way 18:34:48

15 process. 18:34:51

16 MR. CROSS: Scott? 18:34:53

17 Mike Cross, Fentress County Executive. 18:34:53

18 In the original plans from I-40 to here 18:34:55

19 at 62, the project broke up into four projects, the 18:34:58

20 fourth one being the Clear Creek Bridge. With this 18:35:03

21 addition, does this affect the bridge section, its 18:35:07

22 construction or timeline? 18:35:11

23 MR. MEDLIN: What we're going to do -- 18:35:14

24 we saw this area here as being an area that was 18:35:15

25 identified that we could actually accelerate and get 18:35:19

1 it through the process earlier than some of the 18:35:23
2 areas to the north of here. What we're going to do 18:35:27
3 when we get the final right-of-way plans turned in 18:35:29
4 for this project, we're going to add that as a 18:35:32
5 revision to this project to the south that goes from 18:35:34
6 Low Road in Cumberland County up to State Route 62. 18:35:38
7 So when we get the right-of-way plans in, we'll add 18:35:42
8 that together, and it will become all one project at 18:35:45
9 that point. 18:35:48
10 MR. CROSS: Okay. 18:35:49
11 MS. FLYNN: Sir? 18:35:52
12 MR. GUNTHER: My name is John Gunther. 18:35:55
13 I travel this road a lot and I was just interested 18:35:55
14 to see if at any time -- I understand you want to 18:36:01
15 put a big bridge over Clear Creek. Is that going to 18:36:05
16 be in the process pretty soon? I know you had 18:36:09
17 bought some land up. 18:36:13
18 MR. MEDLIN: Yes, sir. We're still 18:36:16
19 planning on crossing Clear Creek with new structures 18:36:17
20 there. It's not been funded for the construction 18:36:21
21 phase yet. 18:36:26
22 MR. GUNTHER: So it's going to be awhile 18:36:27
23 before you start building a bridge? 18:36:27
24 MR. MEDLIN: It could be. Now that's 18:36:31
25 all part of the federal transportation funding. We 18:36:32

1 have to have a multi-year transportation bill that 18:36:33

2 will help fund some of these projects. These 18:36:37

3 projects such as this are funded 80 percent with 18:36:40

4 federal dollars; so we rely heavily on federal 18:36:42

5 funding to help pay for highway projects such as 18:36:47

6 this. 18:36:47

7 MR. GUNTHER: Well, that's what I'm -- 18:36:49

8 how long of a bridge is that going to be? 18:36:49

9 MR. MEDLIN: I've got the plans sitting 18:36:53

10 over here. I would have to look that up for you. 18:36:54

11 MR. GUNTHER: Over a mile from my 18:36:56

12 understanding. 18:36:59

13 MR. MEDLIN: I would have to look that 18:36:59

14 up to make sure. 18:37:01

15 MR. GUNTHER: I'm already 72 years old. 18:37:03

16 I probably won't live that long to see it. 18:37:05

17 I wish you would have -- the roads would 18:37:09

18 have been near danger, they would be fixed. It's 18:37:12

19 cost a lot of lives. It should have been avoided. 18:37:17

20 I was just curious of what's going on. 18:37:26

21 That's why I came. 18:37:28

22 MR. MEDLIN: Well, we're glad you came. 18:37:30

23 MS. FLYNN: Yes. 18:37:33

24 MR. MEDLIN: Any other questions? 18:37:33

25 MR. GUNTHER: So there's no construction 18:37:35

1 that's going to start in the next year or two? 18:37:36

2 MR. MEDLIN: No, sir. We've got about a 18:37:39

3 year-and-a-half to go through the right-of-way 18:37:40

4 process on just this section here. 18:37:42

5 MR. GUNTHER: But you have bought up 18:37:44

6 quite a bit of houses already, didn't you? 18:37:45

7 MR. MEDLIN: Yes, sir. On section there 18:37:48

8 that crosses where Clear Creek is on that particular 18:37:48

9 project, we're down to the last four or five pieces 18:37:50

10 of property. 18:37:54

11 MR. GUNTHER: You started by 62 almost. 18:37:56

12 MR. MEDLIN: Yes, sir. 18:38:00

13 MS. FLYNN: Anybody else have any -- 18:38:04

14 MR. GUNTHER: Is that one of the first 18:38:05

15 projects you're going to start, the bridge? 18:38:07

16 MR. MEDLIN: The first project 18:38:12

17 between -- 18:38:13

18 MR. GUNTHER: Are you going to start the 18:38:14

19 first project -- 18:38:15

20 MR. MEDLIN: Between here and I-40 or -- 18:38:17

21 MR. GUNTHER: From Clarkrange to the 18:38:19

22 bridge, the big bridge. 18:38:22

23 MR. MEDLIN: When we let it to contract, 18:38:25

24 we will have a specified number of days that the 18:38:27

25 contractor has to work and it will be up to the 18:38:29

1 contractor of how to schedule the project in order 18:38:32
2 to meet the completion date of the schedule. So it 18:38:35
3 will be up to whoever the lowest bid is on the 18:38:38
4 contract to determine exactly where they want to 18:38:41
5 start on the project. 18:38:44

6 MS. FLYNN: Anybody else? Any 18:38:52
7 questions, comments? 18:38:55

8 Okay. Thank you very much. We will be 18:38:56
9 here and you can look at the plans here and talk to 18:38:59
10 any of our representatives about anything. 18:39:03

12 (WHEREUPON, the following comments were
13 made after the presentation concluded:)

14 MS. TREADWELL: As I told 17:48:09
15 Mr. Sutherland, I'm Karen. I live basically at the 17:48:11
16 corner of 62 and 127; not right there, but less than 17:48:15
17 a tenth of a mile from it. I know this project 17:48:21
18 needs to go through very, very, very soon. We have 17:48:24
19 a new bank coming right at the corner of 62 West. 17:48:28
20 We have a brand new Dollar Store right there on 127 17:48:32
21 almost at the northeast corner. Traffic is 17:48:37
22 already -- you can't get through it. If we only 17:48:40
23 have two lanes there as opposed to five, then it's 17:48:43
24 going to be a nightmare. You are never going to be 17:48:48
25 able to get through the intersection. People are 17:48:50

1 going to be angry and upset. It's going to kill the 17:48:54

2 127 Yard Sale because you can't get through it now 17:48:58

3 as it is. 17:49:01

4 If those two businesses open, I'm so 17:49:01

5 grateful that they are, and I hope they thrive and 17:49:05

6 prosper. I am so for this. We need to get this 17:49:06

7 pushed through as quickly as possible to eliminate 17:49:09

8 the traffic problem for safety and environmental 17:49:12

9 reasons, not to mention economic reasons. 17:49:17

10 Thanks. 17:49:19

11 MR. HARGIS: The 40-foot entrance that 18:01:54

12 they have marked as of now on their paper is not 18:01:57

13 enough entrance for me to get a truck in and out 18:02:02

14 without crossing the other lanes of traffic. As of 18:02:06

15 right now, my entrance runs within five foot of the 18:02:10

16 full driveway of my property, which was actually put 18:02:18

17 in by the State, and I would like for it to be back 18:02:23

18 like it is right now. 18:02:29

19 That's all. 18:02:32

20 MR. JONES: I am against the five-lane 18:44:54

21 roads with the bicycle path and sideways and 18:44:59

22 gutters. Four lanes is plenty. Okay. 18:45:04

23 MR. WAKEFIELD: My concern is that I 18:45:13

24 have the Exxon station at the four-way and my 18:58:28

25 signage, where my big electronic sign is right now, 18:58:32

1 I'm wondering -- I'm switching over to Marathon 18:58:36
2 probably within the next couple of months and I was 18:58:41
3 just wondering did I need to relocate my sign when 18:58:44
