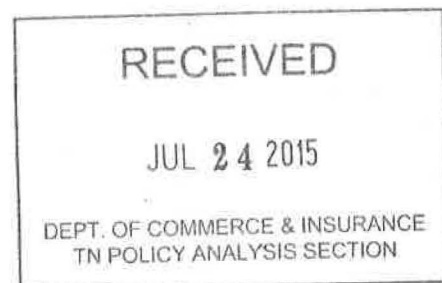


The administrative appeal costs of this cause are taxed against Creekside Glass Company, LLC, for which execution may issue, if necessary.

It is so ORDERED.




