SUPPLEMENTAL ORDER FOR SAFETY NATIONAL CASUALTY CORPORATION  
ADMINISTERING BOND SECURING WORKERS' COMPENSATION SELF- INSURANCE  
on 1) NOTICE TO RECENT TENNESSEE EMPLOYEES OF PLASTECH ENGINEERED  
PRODUCTS, INC. AND TO APPROVE PUBLICATION NOTICE and  
2) REPORTS ON CLAIMS TO COURT

This order is a Supplement to the Revised Consent Order entered December 2, 2008 by  
the Court, and agreed to by the Tennessee Commissioner of Commerce and Insurance, and the  
Respondent Safety National Casualty Corporation (SNCC), through their respective counsel,  
subject to approval of this Court, WHEREFORE the following provisions should be ordered:

1. In addition to the notices required by the provisions of the Revised Consent  
Order, the Court requires SNCC to mail or to cause to be mailed, by first class U.S. mail, notice  
of the Revised Consent Order describing the bond company's role and its designated contact  
information to the employees of Plastech Engineered Products, Inc. (Plastech) who were  
employed at the employer's Tennessee plans immediately prior to their closure. This Order

requiring SNCC to mail such notice does not represent a ruling by this Court to excuse the failure of any injured worker to notify their employer under the Tennessee Workers' Compensation law after an injury or excuse the failure of any injured worker to otherwise comply with statutory or regulatory requirements for asserting a claim, such situation to be governed by the law and its particular facts. The address lists containing the last known names and addresses of the employees at the Tennessee plants immediately prior to each plant's closure supplied by the bankruptcy counsel for Plastech, will be used for the mailing.

2. As specified in the Revised Consent Order SNCC shall publish or cause to be published a legal notice of the Order directing it to administer the SNCC Bond securing the self-insured liabilities of Plastech for workers' compensation in Tennessee, and of instructions for contacting SNCC or its designated administrator. The legal notice shall be published once per week for (2) weeks, as soon as practicable after this order is entered, in a newspaper of general circulation covering Plastech's plant locations in Kenton, Franklin and Gallatin, Tennessee. The Notice shall contain substantially the following text:

**NOTICE TO EMPLOYEES OF  
PLASTECH ENGINEERED PRODUCTS, INC.**

**Notice regarding further administration of Tennessee Workers' Compensation Benefits for Employees of Plastech Engineered Products, Inc., formerly known as United Screw & Bolt Corporation, which operated plants in Gallatin, Kenton, and Franklin, Tennessee:** These plants were closed during or before September, 2008 following the employer seeking bankruptcy protection. The employer stopped paying its own self-insured workers' compensation payments, and the administrator previously used by it, Constitution States/Travelers, is no longer involved.

Under a December 2, 2008 Revised Consent Order of the Davidson County Chancery Court in Action No. 08-2516-I, the Safety National Casualty Corporation (SNCC) has agreed to administer its bond for the employer's self-insured Tennessee workers' compensation liability. **To access any workers' compensation benefits or medical care to which an injured worker may be entitled, or by which an injured worker may be entitled by prior judgment, an injured worker is required to contact SNCC's chosen administrator, CCMSI, with any and all notices, claims for coverage,**

or questions regarding this employer's Tennessee workers' compensation benefits. **Do not delay if any matter requires attention. The contact information is As follows:**

In order to assist with the Court's oversight of the bond, the Court requires SNCC to report at six month intervals to describe the claims activities undertaken by it, the number of active claims, and expenditures for claims and administration against the Bond penalty sum during the reporting period. *The first report should contain a list of the employees who were sent notice by mail pursuant to paragraph 1 of this order.* These semi-annual reports shall be brought to the Court's attention by placing such Report, by motion, on the motion docket of the court, and serving the counsel for the Petitioner. The Petitioner shall file a written response or acknowledgment of the Report for the record of the Court.

4. As ordered in the Revised Consent Order, SNCC or the Commissioner may move this Court for any further instructions, orders or modifications of this order as may be necessary to accomplish the purposes of the administration of Bond proceeds.






