MOTION FOR APPROVAL OF 100% DISTRIBUTION AS TO APPROVED
AND FINALIZED CLASS 2 CLAIMANTS OF THE ESTATE OF THE RECIPROCAL
ALLIANCE (RRG), IN LIQUIDATION AND TO ENTER ORDER APPROVING
SUCH AS A FINAL ORDER

I. Introduction

Julie Mix McPeak, as Commissioner of the Tennessee Department of Commerce and Insurance, in her capacity as Liquidator of The Reciprocal Alliance (RRG) in Liquidation ("TRA"), and through her appointed Special Deputy Receiver of TRA, makes this filing to:

- 1) approve further distribution to make a 100% total distribution as to each previously approved Class 2 claim which has been paid a previously approved 50% interim distribution,
- 2) approve a 100% total distribution as to each newly approved Class 2 claim which has not heretofore had amounts previously distributed on it, and

- 3) submit and seek approval of **Exhibits A and B** attached hereto as the TRA Liquidator's report and listing of all Class 2 claims that will be subject to the distributions requested herein (see T.C.A. § 56-9-331).

II. Discussion

The TRA Liquidator and her appointed Special Deputy Receiver assert that, using the allocation methodology of assets among the three RRGs approved by the Court in its November 9, 2011 Order,¹ and allowing for reserving for future expenses of the TRA Receivership and for one particular Class 2 claim not yet submitted for approval,² sufficient assets are available to make a 100% distribution as to all approved TRA Class 2 claim amounts.

Attached to this Motion are two listings of approved and finalized Class 2 claims. First, attached as **Exhibit A** is the listing of the TRA Approved Class 2 Claims which have already been approved by this Court for a 50% distribution from the TRA Liquidation Estate³ and which have had that 50% distribution payment made to them. As to this **Exhibit A** listing of approved TRA Class 2 claims, the Liquidator and her appointed Special Deputy Receiver seek approval to pay the remaining

¹ In its November 9, 2011 Order, this Court approved a "net Class 2 claim loss" method by which to allocate asset recoveries as between the three related RRGs that are before the Court in receivership/liquidation proceedings - - American National Lawyers Insurance Reciprocal (RRG), in Liquidation (Case # 03-293-IV), Doctors Insurance Reciprocal (RRG), in Liquidation (Case # 03-294-IV) and The Reciprocal Alliance (RRG), in Liquidation (Case # 03-295-IV).

² Proof of Claim No. 1776 is the one remaining not yet finalized Class 2 claim, as to which a Notice of Determination was issued on March 1, 2007, and an Objection to the Determination was filed on March 26, 2007. The hearing on the Objection was scheduled on November 2, 2007, whereupon counsel for the claimant requested and was granted a continuance. Due to serious health issues of counsel for claimant, the objection has yet to be heard by the Referee and resolved. Pending recovery of counsel or substitution of counsel, sufficient assets are reserved and available to pay 100% of the maximum claim amount, if ultimately allowed.

³ As the Court is aware, the TRA Liquidator and her appointed SDR have filed several motions, beginning with their October 5, 2011 motion, which sought approval of payment of a 50% distribution to the approved Class 2 claims that were listed in attachments to those various motions. Those motions were granted and 50% distributions have been made on those approved Class 2 claims. What is attached as **Exhibit A** to this Motion is the aggregate listing of all of those approved Class 2 claims that have previously been approved by the Court for the 50% interim payment.

50% of the approved claim amounts so that the total distribution would be a 100% payment of the approved and finalized Class 2 claim amount.

The second listing of TRA Approved Class 2 Claims - - **Exhibit B** hereto - - consists of Class 2 claims that have recently been approved and finalized and which have not been previously submitted for approval for an interim distribution. Therefore, the amount sought to be paid to the **Exhibit B** listings of approved Class 2 claims is 100% of the approved claim amount.

As was noted and allowed in the Court's November 5, 2011 Order, and subsequent Orders approving interim distributions on approved TRA Class 2 claims, the TRA Liquidator and her appointed Special Deputy Receiver request that they be given the discretion to delay any of the payments approved by the Court until it is determined whether the claim involves a potential Medicare, Medicaid or similar lien and/or whether provisions for payment of any such lien have been made.

The aggregate amount of distribution set forth in **Exhibit A** and **Exhibit B** is \$17,363,106.88. Given allowance for the one Class 2 claim not yet finalized and approved, and given allowance for a generous estimation for expenses of the TRA Receivership, nevertheless a 100% payment of the approved Class 2 claims listed in **Exhibit A** and **Exhibit B** can be made consistent with T.C.A. § 56-9-330(a). Accordingly, it is requested that the approved Class 2 claim listings attached as **Exhibits A** and **B** be accepted as a report and listing of claims to be paid pursuant to T.C.A. § 56-9-331, and be paid at 100% of the approved claim amount as shown in those exhibit listings.

III. Notice of Motion

Notice of this Motion will be given to every TRA claimant regardless of class of claim. Every such claimant will have a postcard mailed to him/her/it, at each claimant's mailing address as shown in the TRA Receivership's records. That postcard notification will inform the claimant of the filing of this Motion, the hearing date, time and place, the deadline for response to the motion, a short

description of the relief sought in the motion and a reference to the Tennessee Department of Commerce and Insurance Website where a complete copy of the motion and exhibits will be posted. Attached as **Exhibit C** is a template of that “postcard” notice.


**IV. Request That Order Granting Relief Be Made
Final Pursuant to Rule 54.02 Tenn. R. Civ. P.**

This Motion seeks relief that will be relied upon in going forward with the progression of the TRA Receivership, including distributions to claimants and ultimate closure. But the relief afforded through granting this Motion does not address all matters at issue in the TRA Receivership proceedings. In order to provide certainty with regard to the relief granted, the TRA Liquidator and her appointed Special Deputy Receiver request that the Court expressly find that there exists no just reason for delay and that the Order granting this Motion be entered as final regarding the matters addressed in that Order. Rule 54.02 Tenn. R. Civ. P.

V. Conclusion

For the reasons set forth, the TRA Liquidator and her appointed Special Deputy Receiver request an Order of Court granting the relief herein requested and to expressly instruct the Clerk and Master to enter such Order as final regarding all matters addressed therein.


