Challenge Process Overview

The Challenge Process is an opportunity for local governments, nonprofits, and internet service providers (ISPs) to view the state's internet coverage and challenge ECD's determination of the internet coverage for locations. Challengers can provide evidence demonstrating that locations are unserved or underserved, which will influence where BEAD funds will be allocated.

- Unserved locations have access to service that is less than 25/3 Mbps.
- Underserved locations have access to service that is less than 100/20 Mbps, but at least 25/3 Mbps.

What Can Be Challenged

The broadband office is accepting challenges under the following challenge types:

- A. Availability The broadband service identified is not offered at the location, including a unit of a multiple dwelling unit (MDU).
- D. Data Cap The only service plans marketed to consumers impose an unreasonable capacity allowance ("data cap") on the consumer.
- T. Technology The technology indicated for this location is incorrect.
- B. Business Service Only The location is residential, but the service offered is marketed or available only to businesses.
- E. Enforceable Commitment The challenger has knowledge that broadband will be deployed at this location by the date established in the deployment obligation. The challenger will need to provide evidence to prove the enforceable commitment.
- N. Not Part of Enforceable Commitment This location is in an area that is subject to an enforceable commitment to less than 100% of locations and the location is not covered by that commitment.
- P. Planned Service The challenger has knowledge that broadband will be deployed at this location by June 30, 2024, without an enforceable commitment or a provider is building out broadband offering performance beyond the requirements of an enforceable commitment.

CAI Challenges include the following:

- C. This location should qualify as an eligible Community Anchor Institution (CAI) The map does not indicate that there is a CAI at this address but the location falls within the definition of CAIs.
- R. This location is not an eligible CAI The map indicates that this is the address of a CAI, but the location does not fall within the definitions of CAIs.

Who Can Participate in the Challenge Process

During the BEAD Challenge Process, the broadband office will only allow challenges from the following entities:

- nonprofit organizations,
- units of local governments, and
- broadband service providers.

When is the Challenge Process

The challenge process conducted by the broadband office will include four phases each spanning 25 calendar days beginning May 7, 2024. The Challenge Process as a whole will span for 75 calendar days.

- Publication of Eligible Locations: Prior to beginning the Challenge Phase, the broadband office will
 publish the set of locations eligible for BEAD funding, which consists of the locations resulting from
 the activities outlined in Sections 5 and 6 of the NTIA BEAD Challenge Process Policy Notice (e.g.,
 administering the deduplication of funding process). This set of locations can be found <u>here</u> on the
 BEAD Challenge Process page.
- Challenge Phase: During the Challenge Phase, the challenger will submit the challenge through the broadband office challenge portal. Challenges will be reviewed to ensure that the challenger provided the appropriate evidence and are therefore valid. The portal will notify the provider of the challenge through an automated email, which will include related information about timing for the provider's response. After this stage, the location will enter the "challenged" state.
 Challenge Phase Window: Challengers will have a 25-calendar day window to submit a challenge from the launch of the challenge portal. This will be from May 7, 2024 June 1, 2024.
- Rebuttal Phase: Only the challenged service provider may rebut the reclassification of a location or area with evidence, causing the location or locations to enter the "disputed" state. If a challenge that meets the minimum level of evidence is not rebutted, the challenge is sustained. A provider may also agree with the challenge and thus transition the location to the "sustained" state.
 Rebuttal Phase Window: Challengers will have a 25-calendar day window to respond to challenges. This will begin after the Challenge phase concludes.
- **4. Final Determination Phase:** During the Final Determination phase, the broadband office will make the final determination of the classification of the location, either declaring the challenge "sustained" or "rejected." Every challenge submitted to ECD will fall under one of the following dispositions:
 - Sustained (S)
 - Rejected (R)
 - Incomplete (I)
 - Provider agreed with the challenge (A)
 - Provider did not respond within the rebuttal deadline (N)
 - Challenge was not resolved because it was moot due to another successful challenge for the same location (M)

Timeline: Following intake of challenge rebuttals, the broadband office will make a final challenge determination during the final 25-calendar day window, after the Rebuttal Phase Window has closed.

5. Public Notice: After this window has closed, the broadband office will publish its tentative list of all accepted challenges and maps as ECD awaits NTIA review. This will be posted publicly on TNECD's website at least 60 days prior to making award announcements.
The following information will be posted for all submitted aballenges and rebuttels before final.

The following information will be posted for all submitted challenges and rebuttals before final challenge determinations are made:

- The provider, nonprofit, or unit of local government that submitted the challenge.
- The census block group containing the challenged broadband serviceable location,

- The provider being challenged,
- The type of challenge (e.g., availability or speed), and
- A summary of the challenge, including whether a provider submitted a rebuttal.

TNECD will not publicly post any personally identifiable information (PII) or proprietary information, including subscriber names, street addresses and customer IP addresses.

How to Participate in the Challenge Process

Pre-Registration

While the Challenge Map is available for all Tennesseans to explore, only pre-registered users are able to submit challenges through the Challenge Portal. **Pre-registration is open from 4/30 – 5/28.** There is no limit on how many people can pre-register per organization, but TNECD asks that each organization designates one person to handle the submission of the challenges. This measure is to ensure that our office does not receive duplicate challenges and evidence from any institutions.

To pre-register, eligible challengers must fill out the Pre-Registration form. This form can also be located on ECD's <u>BEAD Challenge Process page</u>. Upon submission of the form, you will receive a confirmation email. Once your pre-registration has been approved, a link to the Challenge Portal will be shared from <u>Gary.Jenkins@tn.gov</u> to the email address used in the pre-registration form. Users may need to request access from this email. Please expect this email to take 1-2 business days after submitting the form.

Submitting a Challenge

Challenges can be submitted from the map, directly from the portal, or a template can be filled out and uploaded to the portal. Submissions of challenges will only be reviewed when submitted by registered challengers with access to the <u>Challenge Portal</u>.

Submitting Challenges from the Map

Individual Challenge from the Map

- 1. Find the map at this link: https://bead.connectednation.org/tennessee/
- 2. Users may type in the address of the location they would like to challenge on the left and select the location on the map. Once the location is selected, the address, location ID, enforceable commitment, and serviceability information will pop up. To add to challenge, click the "Add Challenge" button.

- 6. Users will then be directed to a form to complete the challenge. This form will have the location or CAI ID already filled out from the map, and the rest of the questions must be completed by the challenger.
 - You will want to use the same email address that was used for registration.
 - If you do not know the internet service provider or the technology, please refer to the map to see the options at the selected location.
 - Selecting the challenge type may prompt additional questions and a description of the acceptable evidence for the challenge will appear.
 - When uploading evidence, you will see a note that the following types of evidence must be uploaded outside of this form.
 - Additional evidence
 - Files larger than 25MB
- .KMZ, KML, Shape File folders (all inclusions .shp, .shx, .prj), Geo JSON files, and .dbf filetypes
- If you intend to upload one of the above evidence types, you will save the challenge as Draft by selecting "Draft" from the Status field. You will have the opportunity to upload evidence once you are in the Challenge Portal.
- If your evidence type does not fall under one of the above categories, you are able to upload the evidence directly into this form.

• User will then either select "Submitted" or "Draft" and submit form. If submitted is chosen as the status, the challenge has been complete. Users will be able to view submitted challenges through a link given upon submission.



- 7. Once this form has been submitted, users will see two links to the portal that will either direct you to draft challenges or submitted challenges. To complete a challenge submitted as a draft, select "Visit the link to view the Draft Challenges"

Area and MDU Challenges

Area and MDU Challenges are administered when multiple valid challenges of the same type and technology are submitted for the same internet service provider. Applies only to availability, data cap, and technology challenges.

Area Challenge

Triggered when there are 6 or more challenges to BSLs using a particular category and single provider within a census block.

Multi-Dwelling Unit (MDU) Challenge

Triggered when there are challenges in a single MDU, based on size:

- Challenge for one unit for MDUs with fewer than 15 units
- Challenges for two units for MDUs between 16 and 24 units
- Challenges for three or more units for MDUs larger than 24 units

Community Anchor Institution (CAI) Opt-In

The TNECD Challenge Portal will simultaneously be hosting a CAI Opt-In process. This is a form for any organization that is currently not recognized as a CAI and you believe qualifies as such. This form can be accessed through the map as seen below or <u>here</u>. The CAI Opt-In form will be open throughout the 75 day Challenge Process.

How it Works X
The Tennessee BEAD Challenge Map contains all up-to-date Broadband Serviceable Locations (BSLs) and Community Anchor Institutions (CAIs) in Tennessee. This map can be used as a resource for participating in Tennessee' challenge process. Any location on this map can be challenged.
How It works:
 Search for an address or locate an area on the map using the zoom function. Click on a location to view the availability of broadband, and whether this location is currently eligible for funding. If you would like to challenge the information you see, select the location(s) and click "Add Challenge." Added locations will show up in the Challenges tab. You can select locations on the map by using the Select tool. Locations can be added one at a time by clicking on them, or you can lasso a group of locations by drawing a loop around multiple locations. This can be supplemented with a geotagged photograph of infrastructure or lack thereof at the location (using a free survey tool like Dioptra, Theodolite, or leveraging location based meta data already present in most devices).
