Dear Ms. Brown,

Pursuant to Tenn. Code Ann. § 49-6-3004(a) (6) In the event of a natural disaster or serious outbreaks of illness affecting or endangering students or staff during a school year, the commissioner of education may waive for that school year the requirement under subdivision (a)(1) of one hundred eighty (180) days of classroom instruction, if a request is submitted to the commissioner by the director of schools. The waiver request may be for the entire LEA or for individual schools within the LEA.

The Jackson County school system has requested approval for the closure of schools on April 29, 2021 and is requesting that an instructional day be waived due to extensive flooding and no drinking water. Due to the flooding and no drinking water that endangered students, the department is accepting this request to waive one instructional day for April 29, 2021.

Pursuant to my above referenced authority, I hereby grant a waiver to Jackson County Schools for one instructional day for April 29, 2021. Please revise the calendar in EIS to indicate the change. Thank you for continuing to notify the Department of your needs related to your school calendar.

Request for Waiver of Required Instructional Days

Severe flooding on 4-28 and 4-29-2021 in Jackson County required schools to be closed on 4-29-21. One school had extensive flooding and three of four schools had no drinking water. Measures were taken to reroute buses due to washed out roads and to provide water for schools by the next day.
