There will be a public hearing before the Technical Secretary of the Tennessee Air Pollution Control Board to consider the pre-hearing draft Knoxville Area Second Ozone Maintenance Plan (2008 Ozone NAAQS) under the authority of Tennessee Code Annotated, Section 68-201-105.

The hearing will be conducted as prescribed by the Uniform Administrative Procedures Act, Tennessee Code Annotated, Section 4-5-201 et. seq. and will take place at the date, time and location indicated above.

The public hearing has been called to consider the pre-hearing draft Knoxville Area Second Ozone Maintenance Plan (2008 Ozone NAAQS). This pre-hearing draft Maintenance Plan was prepared in accordance with Section 175A of the Clean Air Act and the U.S. Environmental Protection Agency's (EPA)

guidance documents. The Maintenance Plan includes an attainment emissions inventory, maintenance demonstration, monitoring data, verification of continued attainment, motor vehicle emission budgets (MVEB's), and a contingency plan. The First 10-year Ozone Maintenance Plan for the Knoxville Area was approved by EPA in 2015. The Knoxville Area Second Ozone Maintenance Plan, if approved, will last from 2025 to 2035.

All persons interested will be allowed to present testimony to the hearing officer regarding the Knoxville Area Second Ozone Maintenance Plan. Anyone desiring to make oral comments at this public hearing should prepare a written copy of their comments to submit to the hearing officer at the hearing. The hearing officer may limit the length of oral comments in order to allow all parties an opportunity to speak, and will require that all comments be relevant to the proposed Maintenance Plan. Written statements not presented at the hearing will only be considered part of the record if received by close of business (4:30 PM Central) on February 20, 2024, at office of the Division of Air Pollution Control at 312 Rosa L. Parks Avenue, 15th Floor, Nashville, TN 37243. Comments may also be submitted via e-mail to Air.Pollution.Control@tn.gov.

Individuals with disabilities who wish to participate in the hearing (or review the file record) should contact TDEC to discuss any auxiliary aids or services needed to facilitate participation. Contact may be in person, by writing, telephone, or other means, and should be made no less than ten working days prior to February 20, 2024, to allow time to provide such aid or services.
