

Solid Waste Permitting Update

TENNESSEE UNDERGROUND STORAGE TANKS and SOLID WASTE DISPOSAL CONTROL BOARD MEETING

- Carter Valley Class I Vertical Expansion (Hawkins Co)
 - Awaiting complete responses to a Notice of Deficiency (NOD) issued in 2022 – Proposal considered dormant pending updates.
- White County Class I Lateral Expansion
 - Underwent a Transfer of Ownership during permitting process requiring a new Part I and new preliminary public notice to be issued reflecting new design proposal and new ownership on 9/19. A revised Hydrogeologic report was deemed complete on 7/29. Part IIB was delivered on 8/27.



- Bi-County Class I Lateral Expansion (Montgomery Co)
 - Part I submitted Nov 2020. Bi-County has informed TDEC in February that the 2020 proposal will be changing, and a new Part I will be submitted. Preliminary site investigation ongoing.
- Middle Point Class I (Rutherford Co) Lateral Expansion
 - All review suspended pending local approval.
- Hamblen County Class I Lateral Expansion
 - Part IIB was deemed to be complete on 9/19/2024



- Smith County Class I Lateral Expansion
 - New Part I received on June 3rd, for a revised 9.3 acre area on 6/3/2024
 - A complete Part IIA was received on 6/24/2024
- Jefferson County Vertical Expansion
 - Revises contours, ponds and closure
 - Part IIB Engineering plans deemed complete on April 12th
 - Notice of Deficiency issued on June 9th



- Lakeway Class I Landfill Lateral Expansion (Hamblen County)
 - Hydrogeologic work plan received 6/15
 - Part IIA (hydrogeologic report) not expected until early 2025
- Loudon County Landfill Lateral Expansion
 - Public Hearing set from October 29.



- Eastman Class II Chemical Ground Water and Narrative Major Mod (Sullivan Co)
 - Awaiting NOD response
 - The requested changes consist of changes to the Variances and Waivers section of the permit triggering a major modification
 - Does not add capacity
 - Proposal considered dormant pending updates.



- PCA Class II Landfill (Hardin Co) Lateral Expansion
 - Received a complete Part I on 10/11/22
 - Hydrogeologic workplan received on 9/11/23
- Poplar View Landfill (Knox Co) Vertical Expansion
 - Complete Part IIB received on 9/3/2024
- Bi-County St. Bethlehem Class III (Change in Post Closure Period)
 - Director's review scheduled 10/3/2024



- City of Milan Class III Vertical and Lateral Expansion
 - Permit for small vertical and lateral expansion issued on 8/1/2024
 - A separate Part II application was received on 10/31/2023 for additional airspace. This is paused at request of applicant pending potential new Part I.
- Alcoa/Blount Class III Lateral Expansion
 - Part IIB Engineering for South Cell does not meet siting criteria, working with applicant on possible resolutions and additional comments.
 - Two part lateral expansion will be issued as two permit modifications if approved.




- Perry County Class III Vertical/Lateral Expansion
 - Engineering under review-awaiting information from county.
 - Ground water monitoring updates underway.
- Jefferson County Class III Vertical/Lateral Expansion
 - Engineering Deemed Complete on 7/23/24
 - Peer review scheduled 10/9/2024
- McMinn County Class III Lateral Expansion
 - Incomplete submittal received. 5/3/24, working with applicant to get Part I in.




- Riverside Class III Vertical/Lateral Expansion (Knox Co)
 - Received Complete Hydrogeological Report 7/13/2023.
 - Notice of Incompleteness issued on Part IIB in September
- North Memphis Class III Vertical Expansion (Shelby Co)
 - Permit issued 7/31/2024
- Claiborne County Class III New Landfill
 - Part I Preliminary Notice pending. Adjacent to existing



Special Waste Applications Trends








Minor Mod Approval Trends
