Are you looking for an opportunity to work with Tennessee State Parks? Our Tennessee State Parks are among the most beautiful parks in the United States. This position is located at Rock Island State Park near McMinnville TN. The park consists of over 2,000 acres and is located on the headwaters of Center Hill Lake at the confluence of the Caney Fork, Collins, and Rocky Rivers. The park has numerous waterfalls, hiking trails, launch ramps, campgrounds, several recreation picnic areas, and a swim beach. The park is dominated by the rugged Caney Fork River Gorge lined with limestone bluffs and natural pools.

Preferred candidates will have proven experience in custodial, janitorial, hospitality, and/or hotel service work as well as experience working in a team setting. Certifications or training in custodial, janitorial, hospitality, hotel service, visitor services, or other related fields is preferred but not required. ### Highlighted Responsibilities:

- Performs routine daily cleaning and sanitizing of park restrooms, shower houses, cabins, buildings, offices, picnic areas, etc. to ensure a positive guest experience.
- Works harmoniously with a team of full-time and part-time employees in performing routine cleaning and upkeep of assigned areas; may train others on processes.
- Forecasts cleaning schedules based on demand and plans effectively to meet demand.
- May assist in keeping inventories of cleaning supplies, linen, paper products and orders regularly to maintain stock.
- Maintains inventories of guest areas and amenities and replaces as needed.
- Performs groundskeeping and other tasks as needed such as cleaning grill/picnic areas, leaf blowing, painting, cleaning windows, etc.
