- Provide interpretive programs for park guests including guided tours, hikes, workshops, canoe floats, demonstrations, campfires and other outdoor activities.

- Handle some general administrative duties to support the needs of the park including writing reports and maintaining assigned park records.
- Work directly with guests of the parks to share the history and story

  options to be able answer general questions about the park.
