#### **Purpose of RFP**

The purpose of this Request for Proposal is to solicit bids for Growing Acres Farm (GA) to obtain and install a truck scale on a leveled site.

### **Project Goals and Objectives**

 Growing Acres would like to obtain and install a digital Truck Scale to make weighing grain a more seamless process.

# **Project Background and Summary**

Growing Acres (GA) has established a strong grain sorghum agronomic program. GA has conducted field trials leading to the selection of a region-appropriate sorghum variety for the region. This knowledge has been transferred to neighboring farmers via education and plans for crop production, market security, and harvesting settings. GA's success has led to a significant storage deficit. Thus, there is a critical need to establish a regional storage facility. To address this glaring need, GA would like to construct a grain sorghum facility that will have a significant economic, environmental, and social impact on Hardin and McNairy County communities as well as the broader region. Specifically, said facility will 1) enhance regional infrastructure, 2) improve market access for farmers by providing a reliable/ competitive outlet for their grain sorghum, 3) contribute to crop diversification leading to improved soil health and water resource management, and 4) strengthen community engagement by fostering skill development and training in modern agricultural practices/ management. GA's due diligence focuses on infrastructure, equipment, and logistics as well as what is the specific market need to be addressed.

The estimation of production process efficiency is grounded in the enhancements introduced by the project, specifically related to streamlined transport and convenient access to a well-equipped regional grain storage facility. With the project's improvements, such as providing

efficient and ample access to transport and grain storage, farmers can seamlessly coordinate their harvests without the unnecessary burden of intense focus on grain logistics.

## **Scope of Work**

- The bids for this RFP should include the cost of materials, labor, and associated costs with construction to build/install the following:
  - (1) Truck Scale. Fairbanks Talon HV Steel Deck Truck Scale 70'x11' or equivalent electric truck scale with digital indicators and approaches with RFID technology
- Growing Acres will provide an already leveled site.
- Ideally, this project would be completed by August 30, 2024, but Growing Acres
  understands that this may not be possible due to time constraints. Please include a
  timeline in your proposal.
- The resulting contract will be for up to a year from the contract signing date. Growing
  Acres may amend or extend this contract beyond the initial year to accommodate the
  terms and conditions of the Tennessee Department of Agriculture's (TDA) FARM Cost
  Share award.

- Technical Response

Include as much or as little information to help us evaluate this as possible.
- Cost Proposal
  - Include a cost proposal for all materials, labor, and other costs associated with the project in your terms.

Please include examples of past projects or references in your proposal, if applicable. While this is a weighted category, it is not a requirement to place your bid to this proposal. We encourage vendors of all kinds who are interested in the opportunity to submit a bid.
- <u>Timeline and Availability:</u> The project's preferred completion date is August 30, 2024 in order to be useful for the 2024 Harvest. This will be taken into account when the bid timelines are reviewed.
