Jefferson County will be soliciting bids for Water Main Replacements in Jefferson County. The Water Main Replacements consists of approximately 39,462 linear feet of 12-inch DR 11 HDPE pipe, service line reconnections, gate valves and all other associated appurtenances, fittings and connections in the Jefferson County community.

This project is being supported with American Rescue Plan Act, Coronavirus State and Local Recovery Fund grant funding. Therefore, certain restrictions and other federal requirements attach to this opportunity.

Separate sealed bids for the New Market Water Main Replacements will be received by Jefferson County at the New Market Utility District Office located at 900 W Hwy 11E, New Market, TN until July 12, 2024 @ 2:00 PM and then at said office publicly opened and read aloud. Any person with disability requiring special accommodations must contact Jefferson County no later than 7 days prior to the bid opening.

Jefferson County is an Equal Opportunity Employer. Any contract that uses federal funds to pay for construction work is a "federally assisted construction contract" and must include the equal opportunity clause found in 2 C.F.R. Part 200, unless otherwise stated in 41 C.F.R. Part 60. We encourage all small and minority owned firms and women's business enterprises to participate. No bidder may withdraw his bid within (60) days after the actual date of the opening thereof.

PLEASE NOTE: Official plans and specifications may only be obtained at Knoxville Blueprint & Supply for a non-refundable cost of \$250/set. It is the sole responsibility of all plan holders, whether they have received digital downloads or paper copies of the plans and specifications, to periodically check for Addenda which will be posted at Knoxville Blueprint & Supply

The Copeland "Anti-Kickback" Act is also applicable, which prohibits workers on construction contracts from giving up wages that they are owed. Contractor's must not appear on Sam.gov disbarment list.

A detailed listing of all subcontractors shall be provided by the Bidder. In accordance with the Contract Documents, documentation that the prospective General Contractor and its subcontractors meet minimum qualifications shall be provided and submitted. Subcontractors must also not appear on Sam.gov disbarment list. Mark-ups on subcontractor work or Cost Plus Overhead will be disallowed for reimbursement.

A bid bond or certified check for five percent (5%) of the total bid amount must accompany each bid. The successful bidder will be required to furnish a performance bond in the amount of his bid and shall, before entering on the work of said contract, be licensed as a contractor of Jefferson County

The owner reserves the right to waive any informalities or to reject any or all bids.
