- 1. INTRODUCTION: West Hills Health and Rehab is currently accepting proposals for a project that is funded under a Grant Contract with the State of Tennessee.
- 2. PROJECT BACKGROUND AND PURPOSE: West Hills Health and Rehab will soon be operating and managing a ventilator weaning/high acuity respiratory unit (ERC) within our Knoxville skilled nursing facility.
