**Town of Tracy City** will be soliciting bids for **Contract 124 – Sewer System Rehabilitation**. Separate sealed bids for **Contract 124 –Sewer System Rehabilitation** will be received by **Town of Tracy City, City Hall, 50 Main Street, Tracy City, TN 37387**, until **2:00 P.M., local time, on July 9, 2024**, and then at said office publicly opened and read aloud. Any person with a disability requiring special accommodation must contact the **Town of Tracy City** no later than 7 days prior to the bid opening.

**CONTRACT 124** consists of the rehabilitation of approximately 800 linear feet of 8" gravity sewer mains by dig and replace, including approximately 3 services, replacement or rehabilitation of approximately 3 manholes and traffic control and paving repairs. This project is being supported with Treasury, Coronavirus State and Local Recovery Fund grant funding. Therefore, certain restrictions and other federal requirements attach to this opportunity.

The allotted time for construction is 60 calendar days.

The Copeland "Anti-Kickback" Act is also applicable, which prohibits workers on construction contracts from giving up wages that they are owed. Contractors must not appear on Sam.gov disbarment list. In accordance with the Contract Documents, documentation that the prospective General Contractor and its subcontractors meet minimum qualifications shall be provided and submitted. Subcontractors must also not appear on Sam.gov disbarment list. Mark-ups on subcontractor work or Cost Plus Overhead will be disallowed for reimbursement.

A bid bond or certified check for five percent (5%) of the total bid amount must accompany each bid. The successful bidder will be required to furnish a performance bond in the amount of his bid and shall, before entering on the work of said contract, be licensed as a contractor of the **Town of Tracy City**.

No bid may be withdrawn within 90 days after the scheduled time for receipt of bids thereof.

The owner reserves the right to waive any informalities or to reject any or all bids.
