  - *Cost of sod and grading to be included in the cost of the sidewalk.*
3. On phase 1 of this project, the concrete pad with the band around it where the shade structure sits ended up being all integral colored concrete with broom finish. The Band was red/burgundy color with the center being the tan color. The sidewalks connecting to this on either side were uncolored concrete.
