The State of Tennessee, Department of Environment and Conservation issues this Request for Information ("RFI") for the purpose of gathering information on XRF analyzer service and maintenance providers. We appreciate your input and participation in this process.

The State of Tennessee, Department of Environment and Conservation (TDEC) is seeking information about service and maintenance providers for XRF analyzers. Specifically, TDEC is seeking information about performing annual calibration of one (1) Niton XL5 XRF analyzer and one (1) Niton XL3t analyzer. TDEC is also seeking information about repairs to one (1) Niton XL5 XRF analyzer and one (1) Niton XL3t analyzer, should any be necessary. Any calibration and repair work for the instruments would be conducted at the potential vendor's business location. Local support at the TDEC offices is not being requested.
