NOTICE: THIS COST PROPOSAL MUST BE COMPLETED EXACTLY AS REQUIRED

COST PROPOSAL SCHEDULE— The Cost Proposal, detailed below, shall indicate the proposed price for goods or services defined in the Scope of Services of the RFP Attachment 6.6., *Pro Forma* Contract and for the entire contract period. The Cost Proposal shall remain valid for at least one hundred twenty (120) days subsequent to the date of the Cost Proposal opening and thereafter in accordance with any contract resulting from this RFP. All monetary amounts shall be in U.S. currency and limited to two (2) places to the right of the decimal point.

As noted below, most of the items on this sheet are meals and further detail, as noted, can be found in Pro Forma Contract Section A.5. and the Pro Forma Contract Attachment indicated. For the items that are meals, the word "each" refers to the meal, including beverages as indicated. For the Supplemental Nutritional Food Items, the word "each" refers to each item listed on Pro Forma Contract Attachment J and would be one protein/granola bar or one piece of fruit or one fruit cup or one individual grilled chicken packet or one individual tuna pouch, and so on. As noted, additional information about the Supplemental Nutritional Food Items can be found in Pro Forma Contract Section A.5. as amended in RFP Amendment 1. Further, for the Supplemental Nutritional Food Items, the Evaluation Factor number represents an estimate of the quantity of individual pieces, not the estimated quantity of bulk packages (case, dozen, gross).

NOTICE:

The Evaluation Factor associated with each cost item is for evaluation purposes <u>only</u>. The evaluation factors do NOT and should NOT be construed as any type of volume guarantee or minimum purchase quantity. The evaluation factors shall NOT create rights, interests, or claims of entitlement in the Respondent.

Notwithstanding the cost items herein, pursuant to the second paragraph of the *Pro Forma* Contract section C.1. (refer to RFP Attachment 6.6.), "The State is under no obligation to request work from the Contractor in any specific dollar amounts or to request any work at all from the Contractor during any period of this Contract."

This Cost Proposal must be signed, in the space below, by an individual empowered to bind the Respondent to the provisions of this RFP and any contract awarded pursuant to it. If said individual is not the *President* or *Chief Executive Officer*, this document <u>must</u> attach evidence showing the individual's authority to legally bind the Respondent.
