Violation: Violating the rules and regulations adopted by the board; All licensees and

certificate holders shall comply with the current code of ethics adopted by the American Counseling Association, except to the extent that it conflicts with the laws of the state of Tennessee or the rules of the Board: The certified professional counselor and licensed professional counselor and anyone under his supervision shall conduct their professional practice in conformity with the legal, ethical and professional standards promulgated by the Board under its current statutes and rules and regulations; Each applicant and certificate holder or licensee is responsible for being familiar with and following this code of ethics: Counselors consider the risks and benefits of extending current counseling relationships beyond conventional parameters. Examples include attending a client's formal ceremony (e.g., a wedding/commitment ceremony or graduation), purchasing a service or product provided by a client (excepting unrestricted bartering), and visiting a client's ill family member in the hospital. In extending these boundaries, counselors take appropriate professional precautions such as informed consent, consultation, supervision, and documentation to ensure that judgment is not impaired and no harm occurs; If counselors extend boundaries as described in A.6.a. and A.6.b., they must officially document, prior to the interaction (when feasible), the rationale for such an interaction, the potential benefit, and anticipated consequences for the client or former client and other individuals significantly involved with the client or former client. When unintentional harm occurs to the client or former client, or to an individual significantly involved with the client or former client, the counselor must show evidence of an attempt to

remedy such harm.

Action: Probation for not less than twelve (12) months; Civil Penalties totaling five

hundred dollars (\$500.00); and costs not to exceed three thousand dollars

(\$3,000.00).

Licensee: John S. Monroe, LPC/MHSP Temp License No. 4847 Memphis

Violation: Any person, except those expressly exempted from this chapter by § 63-1-

110 or § 63-1-111 who practices the healing arts as defined in this chapter, or any branch thereof, without first complying with this chapter, including all laws now in force regulating the practice of the various branches of the healing arts, and any person who violates this chapter commits a Class B misdemeanor; Violating the rules and regulations adopted by the Board; If an applicant is granted a temporary license, the license shall remain valid for up to four (4)

vears and shall be eligible for extension at the discretion of the board: The place or practice shall have at least one licensed mental health professional on site for a cumulative minimum of 20 hours per week whose assigned job duties include being available to the applicant for supervision and/or consultation while the applicant is engaging in the practice of counseling or counseling related services. In addition, the place or practice shall have a written emergency plan in place to include method(s) of contacting supervisor(s) or other consultant(s), alternative contacts when supervisor(s) is(are) unavailable, information regarding crisis services, and crisis decisionmaking. The licensed mental health professional can serve as the applicant's supervisor if he or she meets the supervisor requirements pursuant to 0450-01-.10. If the licensed mental health professional on staff at the place or practice is unable or unwilling to serve as the applicant's supervisor, the applicant must secure a supervisor who meets the supervisor requirements pursuant to 0450-01-.10. For an applicant pursuing post-master's professional experience, the place or practice shall not be owned, or independently operated by the applicant. [...] Prior to choosing a clinical setting, if an applicant is uncertain, he or she shall seek advice about what is considered acceptable from the Board; Professional counseling is one of the healing arts and as such the practice of which is restricted to those persons credentialed by the board. Persons engaging in the practice of professional counseling without being credentialed or expressly exempted by the law are in violation of division law T.C.A. § 63-1-123; If an applicant is granted a temporary license, the license shall remain valid until the Board grants or denies the regular license application or until it shall become invalid for any of the following reasons: Failure to continue in supervision during the [...] period the license may be valid.

Action:

Cease and Desist practice until obtaining full licensure and completing the requirements of the Board Order; 6 CE hours; Pay civil penalties totaling five thousand dollars (\$5,000.00); pay costs up to five hundred dollars (\$500.00)

Licensee: Violation:

Tammi Newton, LPC/MHSP 2414, Pegram

Respondent's license expired March 31, 2013. Respondent began working as a professional counselor for Belleview Behavioral Health (BBH) in approximately July 2017 without a valid license. In August 2021, Respondent submitted an application to have her license reinstated and appeared before the Board on March 4, 2022, to request that her reinstatement application be approved. The Board instructed Respondent to CEASE AND DESIST from the practice of licensed professional counseling, allowed Respondent to withdraw the reinstatement application, instructed Respondent to reapply by completing the application for Licensure by Examination, and submit some additional required information. Respondent failed to submit a new application or the additional requested information. When Respondent began working as a professional counselor without a valid license she violated Tenn. Code Ann. § 63-22-117 (a)(1)(A) Representing or advertising such person as, or using a title or description such as, "licensed professional counselor" without being duly licensed according to this part; (B) Making use of any title, words, letters or abbreviations, or any combination thereof, that may reasonably be confused with licensure provided by this part to denote a standard of professional or occupational competence, without being duly licensed under this part; and (C) Performing activities that may reasonably be construed to fall within the defined

scope of practice of persons licensed under this part who are designated as mental health service providers as defined in § 63-22-122 without being duly licensed hereunder. Respondent's conduct also violated Tenn. Code Ann. §63-22-110(b)(4) Engaging in professional misconduct, unethical or unprofessional conduct, including, but not limited to, willful acts, negligence and conduct likely to deceive, defraud or harm the public or engaged in such conduct.

Action:

Voluntary Surrender of LPC/MHSP license; Civil Penalties totaling two thousand five hundred dollars (\$2,500.00); and costs not to exceed two thousand dollars (\$2,000.00).
