Board's employee phone numbers and e-mail addresses remained the same, however if you are sending or having documents sent to this office; PLEASE HAVE ATTENTION: MEDICAL LABORATORY BOARD, on the address as an identifier because there are some thirty (30) other state licensure boards at the same address. Documents are easily misplaces when not directed to this board and could greatly increase the processing time of any application or actually cause a second submission of documents to the administrative office.

Staff works diligently to try to process the applications within the Department's established bench marks; however any delay in receipt of the documents only lengthens the licensure process for the applicant.

Remember, Tennessee is a primary source licensure state and ALL qualifying documents must come from the originating entity (source), college registrar's office, certifying agency, etc. Copies of these documents will only delay the process.

Medical Laboratory Board Legislative Update - 2014

Public Chapter 154

This act allows the Commissioner of Health or his designee to have electronic access to medical records in order to facilitate investigations when responding to an immediate threat to public health. Today the Commissioner of Health or his designee already has this authority but must go to the facility to review the medical records. This act took effect on April 16, 2013.

Public Chapter 94

This act defines "abuse" and "neglect" for purposes of placing a person on the registry of persons who have abused, neglected, or misappropriated the property of vulnerable individuals specifically within the statutes that govern the Dept. of Health. It does not impact the definitions within the statutes that govern the Dept. of Intellectual and Developmental Disabilities nor the Dept. of Human Services. It also increases the time within which placement on the registry may be appealed from 30 to 60 days. For rulemaking purposes, this bill became effective on April 10, 2015. All other provisions become effective on July 1, 2015.

Public Chapter 502

This act allows the Joint Government Operations Committee (the legislative committee that reviews all rules) to stay a rule up to 75 days instead of 60 days. Present law authorizes the Joint Government Operations Committee to consider justification, necessity and reference. This act adds arbitrariness and capriciousness as two new considerations.

Policy Laboratory Reports Patient Test Management

Tennessee Code Annotated Section 68-29-121(b) provides: "(t)he results of a test shall be reported to the physician, optometrist, dentist, chiropractic physician, designated entity or other health care professional who requested it."

The statute indicates the only persons to whom a laboratory may lawfully send the results of any test it performs, except other laboratories as authorized by Tennessee Coed Annotated Sections 68-29-129(5).

Pursuant to CLIA (Clinical Laboratory Improvements Acts) regulations §493.1291 and 45CFR§164-524, patients may now be allowed access to their personal health information, including access to their laboratory test reports.

Tennessee Code Annotated Section 68-29-121(b) should not be interpreted to preclude a medical laboratory from also providing test results directly the patient.

This revised policy statement was adopted on July 16, 2015.

INVOICES FOR LICENSE RENEWAL

On January 1, 2013, the law became effective requiring your licensing board to provide electronic notices to you. The law gives you the <u>option</u> of being notified electronically of the following: (1) Renewals of license, certification or registration; (2) Any fee increases; (3) Any changes in state law that impact the license holder; and (4) Any board meeting where changes in rules or fees are on the agenda. If you "opt in", the Department of Health will also be able to alert you of critical public health matters impacting the State of Tennessee.

If you choose to "opt-in", you must keep your e-mail address site current or you will not receive a renewal notice for no paper notice will be generated via our electronic database and be mailed to your home. It is responsibility for the licensee to maintain the licensee in current status at all times.

It is also imperative you keep your address current in our system which will provide an avenue for receiving license updates and other important information concerning your license.
