Medical Laboratory Board Legislative Update - 2014

Public Chapter 949

This act allows for initial licensure applications to be accepted online. Currently, renewing licenses is already available online. This also makes available to the public annual inspections of health care facilities and pharmacies, similar to how nursing home inspections are already available.

Public Chapter 1007

This bill subjects out-of-state labs providing services to patients in TN, to the same provisions as labs located in this state. Specifically, this bill makes out-of-state labs subject to the prohibition on offering rebates that in-state labs are subject to. This removes a loophole that out-of-state labs were able to use to gain a competitive advantage over instate labs.

Policy Revision Coursework for Licensure

The Tennessee Medical Laboratory Board accepts coursework required to become licensed to be presented in traditional lecture and classroom formats, as well as coursework presented in multimedia and/or electronic formats.

This Policy Statement was adopted by the Tennessee Medical Laboratory Board on the 16th day of January, 2014.



The Tennessee Open Meetings Act passed by the General Assembly in 1974 requires that meetings of state, city and county government bodies be open to the public and that any such governmental body give adequate notice of such meeting. Open meeting notices can also be accessed at

INVOICES FOR LICENSE RENEWAL

On January 1, 2013, a new law, became effective requiring your licensing board to provide electronic notices to you. The law gives you the <u>option</u> of being notified electronically of the following: (1) Renewals of license, certification or registration; (2) Any fee increases; (3) Any changes in state law that impact the license holder; and (4) Any board meeting where changes in rules or fees are on the agenda. If you "opt in", the Department of Health will also be able to alert you of critical public health matters impacting the State of Tennessee.

If you should not get a renewal notice, written or email, please maintain your vigilance in reviewing your expiry date and be aware that it is your responsibility to renew your license before it expires, with or without a renewal invoice. Your expiration date is on your license and you can renew online following this link:
