LEGISLATIVE UPDATE

The following is a summary of bills relative to the practice of veterinary medicine in the state of Tennessee:

Public Acts 2009

Public Chapter No. 67

This public chapter amends Tennessee Code Annotated, Title 53, Chapter 11, Part 3 by adding a new section providing that it is unlawful for a person to deceive or fail to disclose to a physician, nurse practitioner or other health care provider that he or she has received the same controlled substance or a therapeutically similar controlled substance within the previous thirty (30) days.

This public chapter also amends T.C.A. § 53-11-309 by adding a new subsection providing that a physician, dentist, optometrist, podiatrist, veterinarian, physician assistant, or licensed

practical nurse or registered nurse working under the supervision of a physician or osteopathic physician shall report to local law enforcement within three (3) business days if they have good reason to believe a person has obtained or attempted to obtain a controlled substance when they obtained the same or a therapeutically similar controlled substance within the previous thirty (30) days.

This public chapter also provides that the health care provider is immune from civil liability if they furnish this information to law enforcement in good faith. A violation of this statute is a Class D felony. A person who fails to disclose or deceives a health care provider to obtain a controlled substance when they have already received a prescription for the same controlled substance is guilty of a Class A misdemeanor. This bill became effective on July 1, 2009.

Public Chapter No. 149

This public chapter prohibits local governments from restricting the authorized practice of veterinary medicine. This public chapter also provides authorization to local governments to regulate the time and place of veterinary business operations provided that such regulation does not conflict with state laws or regulations governing the practice of veterinary medicine.

Note: 2008 Public Chapter No. 1035 which requires that all prescriptions written or printed be on tamper-resistant prescription paper does not apply to prescriptions written by veterinarians.

PROFESSIONAL PRIVILEGE TAX

Under T.C.A. 67-4-1702, anv qualified professional with an active license on June 1 of each year must submit a professional privilege tax return and payment of \$400 for the privilege of holding an active license in Tennessee. Failure to pay your professional privilege tax constitutes grounds for suspension of your license to practice veterinary medicine in Tennessee. If you fail to pay your professional privilege tax, the Department of Health will file formal charges against you seeking the suspension of your license pursuant to T.C.A. § 67-4-1704. Avoid the possible suspension of your privilege to practice veterinary medicine in Tennessee by remitting your tax to the Department of Revenue in a timely fashion. CONSUMER RIGHT-TO-KNOW

The Heath Care Consumer Right-to-Know Act of 1998, T.C.A. § 63-51-101 et seq., requires veterinarians to submit information regarding details of their training, specialty certification and practice prior to licensure and/or renewal of licensure. Licensees who have submitted information are required to update that information in writing by notifying the Department of Health, Healthcare Provider Information Unit, within thirty (30) days after the occurrence of an event or the attainment of a status that is required to be reported. Failure to comply with the requirement to update profiling information constitutes grounds for disciplinary action against your license. information on updating your practitioner profile, please visit our web site at:

CONTROLLED SUBSTANCE DATABASE REPORTING

Reminder: Any practitioner licensed in Tennessee who dispenses controlled substances is required to submit information to the Controlled Substance Database at least twice monthly. The submitted data should include the prescribing practitioner; who filled the prescription; basic patient/client information; and the name and form of medication that the patient/client received. Failure to submit information to the database is grounds for disciplinary action against your license.

DID YOU KNOW.....

 "Veterinary technician" means a person who is a graduate of a veterinary technology program accredited by the American Veterinary Medical Association; and it is a Class B misdemeanor for any person to use in connection with the person's name any designation intending to imply that the person is a veterinary technician or a licensed veterinary technician unless the

- person has successfully completed the licensure process.
- Complaints for all Health Related Boards are handled through the Office of Investigations and must be in writing. You may contact the Office of Investigations toll-free at 1-800-852-2187.
- Complaints made against a licensee become public information only upon the filing of a notice of charges by the Dept. of Health.
- A total of one hundred three (103) complaints pertaining to the Board of Veterinary Medical Examiners were received in the Office of Investigations during calendar year 2008.
- The Board's disciplinary coordinator is currently "monitoring" thirty-four (34) licensees.
- A certified animal control agency must also hold a valid premise permit issued by the Board in order to apply for chemical capture certification.
- All licensees are required to notify the Board in writing within 30 days of any name change or change of address.
- A total of three hundred sixty-seven (367) facility inspections (initial and renewal) were conducted during calendar year 2008.
- Renewal notices are mailed approximately sixty (60) days prior to the expiration date of the license.
