For this reporting period, there was one (1) Occupational Therapists Assistant whose license was suspended for having been issued a Child Support Default Order by Tennessee Department of Human services. The license suspension had since been lifted after compliance.

## **CE AUDIT**

For this reporting period, 51 Occupational Therapists audited were 88% compliant and 25 Occupational Therapy Assistants audited were 80% compliant.
