Office of General Counsel Report

Lara Gill, board advisory attorney, presented the Office of General Counsel report as follows:

Lara Gill informed the Board of Senate Bill 1680, this Bill will determine the future of Physical Therapy Compacting Privileges. Should the Bill pass, Compacting Privileges in Tennessee will be extended to June 30, 2028.

Orders of Compliance

Lara Gill presented to the board the current orders of compliance for Board approval.

- Bobbie Bowling License No. 2062-PTA There was an error in the previous August 9, 2019 order that has since been corrected, and licensee is in good standing, according to Lara Gill. - ii. Madeline Colson Murphy License No. 5659-PTA Murphy (present) has complied with all requirements. After review, LeAnn Childress made motion to accept the order as written, Jane David second the motion. The motion carried.
