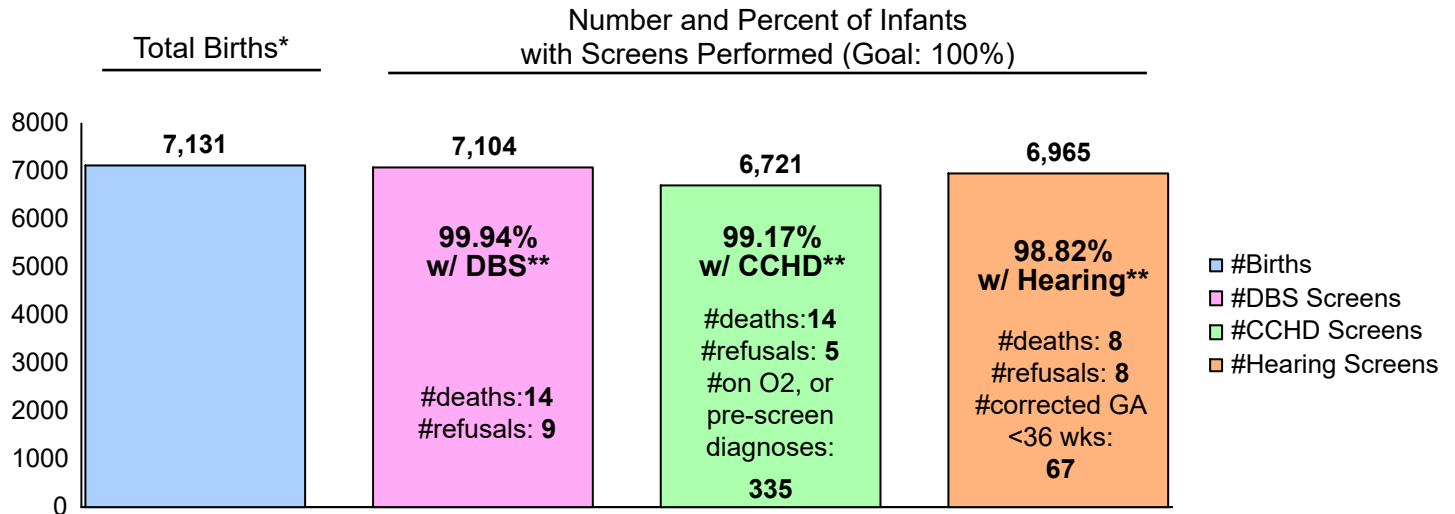


Tennessee Newborn Screening Program Report for STATE OF TENNESSEE (Hospitals Only)

Tennessee State Law (TCA 68-5-401) **requires** that all infants born in the State of Tennessee receive screening for certain conditions using a dried blood spot (DBS) screen, for critical congenital heart disease (CCHD) using pulse oximetry and for congenital hearing loss via hearing screening. Screens Performed for Date of BIRTH Range: 3/1/2024 - 3/31/2024



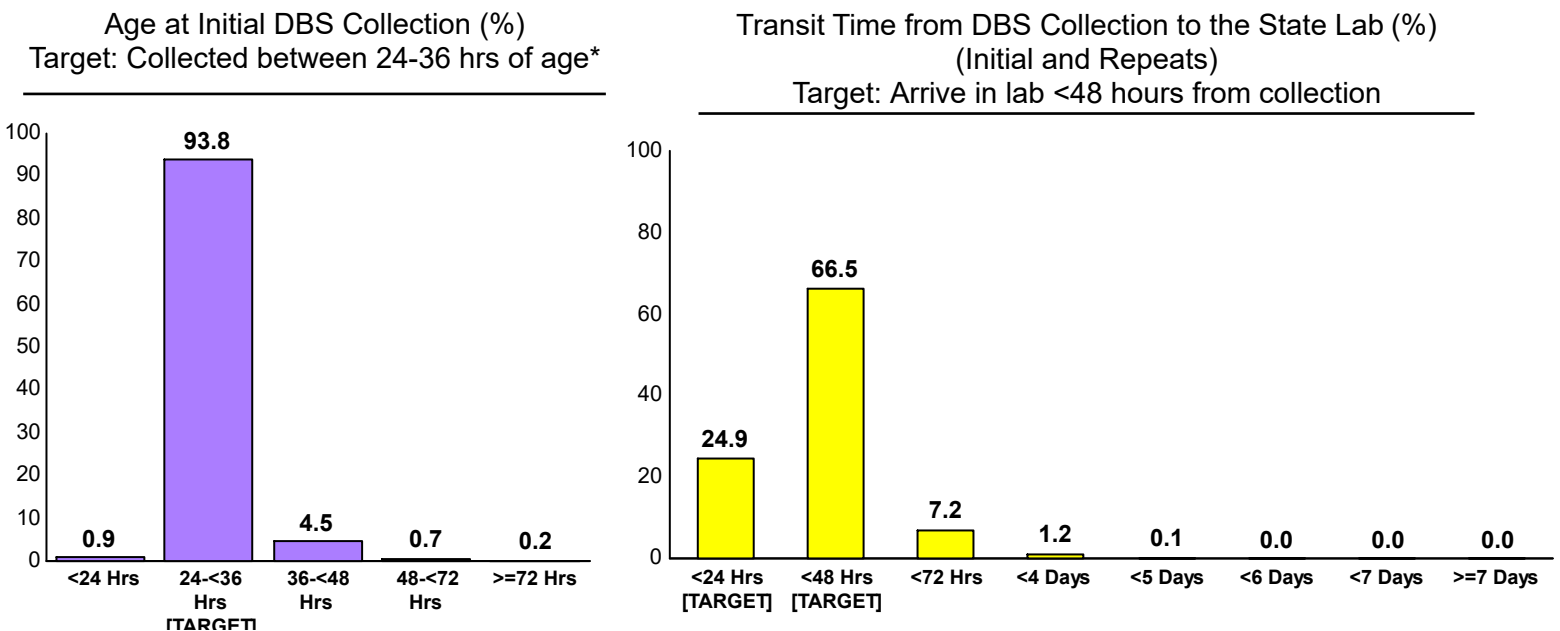
