Summary: Today's, discussion was about the different organizations talking about what they do and how the Health

Disparities Task Force Team can assist and help collaborate working together in the communities for the Tennesseans.

- > Community Rural Health for the Free Medical Clinic of Oak Ridge, that provide free medical care for the uninsured and underserved. We are currently fixing to launch our mobile clinic, starting the 1st of February in several different areas in the Rome, Morgan, Anderson County. We need is for you to let people in those areas know that we are here and we're here and available to help them get the primary care they need.
- The Department of Education for the state is launching, in April 2023, an initiative to increase the conversation and resources for health equity in after-school programming across our state. Dept of Education is launching an after-school pledge in which organizations are going to get a PD about health promotion. The Dept of Education is also providing aid, to make sure these organizations enroll in the summer Food Service program to make sure students are getting meals. - ➤ In Vanderbilt Kennedy Center, the University Center for Excellence in Developmental Disabilities, is an area we provide technical assistance and community information to people who have questions about intellectual and developmental disabilities. If you encounter someone who has an intellectual or developmental disability who needs resources or help, you can contact the Vanderbilt Kennedy Center, more specifically, we have Tennessee Disability Pathfinder www.tnpathfinder.com.

If someone is looking for an evaluation, sometimes they can get an evaluation through research without having to pay for it or go through insurance. Interventions that are being studied, which you can complete through the Vanderbilt Kennedy Center. We have what's called the Study Finder, you can put in whatever disability you're interested in, and pull up the research and it will also let the individual know whether they qualify or not. Open Enrollment for 2023 is over. TennCare is open year-round and if you have a qualifying event you can sign up for health insurance with financial assistance via healthcare .gov. Qualifying events include:

- losing health coverage,
- moving.
- getting married,
- having a baby,
- or adopting a child

- Signing up for health insurance
- Signing up for all categories of TennCare/ Cover Kids
- Signing up for food stamps SNAP
- Signing up for unemployment
- Locating free or sliding scale clinics for the uninsured
- Locating charitable organizations that can assist in paying for medical treatment for the uninsured
- Locating a PCP for your current coverage
- Answering questions about Medicare
- Answering questions about QMB, SLMB and how they can help with the cost of your Medicare
- Finding a care bed for those dealing with addiction

• CMS Federal Government Medicare & Medicaid: The Consolidated Appropriation Act came out this year, the act has a provision that's detaching from the continuous Medicaid coverage with the public health emergency, meaning the public health emergency will continue, but the Medicaid will terminate as early as April 1st. Now that we're talking about people with certain diseases and the need of healthcare and access to healthcare, I make a request that you assist those individuals because they will need help with the termination for Medicaid.

The individuals that are on Medicare and Medicaid dual eligibility, who is or were in a nursing home or they were disabled, that process is going to stay the same, but anyone that used to get our termination paperwork before will be terminated. Now our concern is that people are not used to the termination for the last couple of years and the letter might come in the mail and then they lose it and find out when they go get help, that they are terminated. So, you are the ones helping them navigate through the system and if you're having any local conversations that you want us to participate in, we'll be more than happy to participate and listen to see how we can support you.
