TOPICS OF DISCUSSION

Focus: The Public Health Emergency Declaration

Presenter: Elizabeth Hart

Summary: The Public Health Emergency Declaration is coming to an end on COVID-19, which has been in effect since January 2020, and it's scheduled to no longer being funded. The following will no longer be available which is access to free COVID-19 testing, no more free vaccines and no access to free mask. Below are the concerns from the Task Force Members about the PHE Declaration ending:

- A main concern is that people are still being diagnosed with COVID-19, going to the hospital, and dying and there will be no more access to testing
- The PHE is not enforced or in place what else is being put in place to allow folks from receiving COVID-19
- COVID-19 vaccines will be at a cost of \$175 once the PHE ends, many residents will have to choose to get a
 vaccine shot for themselves or purchase food for their household
- A concern folks receive reliable and truthful information from the government if there's another pandemic
- Unqualified minorities do not have health insurance coverage, and most have not received the COVID-19 vaccine
 or booster shots
- Many people are worried about "No Demand to Wear a Mask" and the need is still there
- Make sure this does not become politicize again
- COVID-19, two tests for \$20.00 at Walmart
- Continuous Medicaid ends on March 31, 2023

What are the needs your communities might need? Please provide your suggestions that they could try or put in place:

- Vaccinations can be provided at the different churches, pop up locations and drive-thru
- Educating all about the vaccine and getting vaccinated to prevent themselves, their family members, and others from contracting COVID-19

Is there still a demand for masks? Are people still wearing mask in the communities in which you serve, work, worship and live? Is there still a demand for mask?

- The demand is not necessarily there but the need for mask is still very prevalent
- The answer to your question is yes people are still wearing mask, teachers at child-care centers, elementary, middle and high schools, students, the elderly, those working in the medical field and those congregating at churches are all still wearing mask because the threat to contracting COVID-19 is still very real

Any concerns that anyone may have about the work force back in building's working? Congregated settings, regarding COVID-19 now that the public health emergency is going to be essentially deactivated any concerns about that, folks in sick time? Workforce regarding COVID-19:

- Health council meetings talking about long term effects due to COVID, folks unable to go back to work
- Employers are having the employees to use their personal PTO sick time with a positive COVID-19 testing
- Employees are opting out not to be paid, which is a concern
- Employers going back to prioritizing productivity over employee's health

The second discussion is the writing of the recommendations report, which has never been done before but we want this recommendations report to be reflective of the task force, in-depth and descriptive using the seven different groups, noted below, which are:

- 1) Priorities
- 2) Community Needs
- 3) Risk and Impacts
- 4) Data Analysis

- 7) Considerations and Recommendations
