Quit Smoking Hotline **1.800.Quit.Now** and www.tnquitline.org FREE online program filled with information resources, experts and connections to help you quit smoking. Below is list of things that take place when deciding to quit smoking:
 - o Risk of heart attack decreases due to reduced constriction of veins and arteries
 - Oxygen and circulation begin to increase and improve
 - o Damaged nerve endings begin to regrow
 - o Sense of smell and taste begin to improve
 - o Two to four weeks after quitting the psychological effects of nicotine withdrawal will stop
- Tennessee State Loan Repayment Program provides educational loan repayment, which is a qualified primary care
 practitioners in exchange for an initial two-year service obligation to practice full time or part time at an ambulatory
 public nonprofit or private nonprofit primary care site located in a federally designated health professional shortage

Summary: The Health Disparities Task Force is in process of preparing a recommendations report for Commissioner Dr. Ralph Alvarado. The Task Force is a result of the COVID-19 impact that it was having on both minority and vulnerable populations. The task force tarted with about 50 individuals, and they were leaders, some elected officials, just to make sure that we were getting information out to the respective communities and then having them spread the information. Today we're working on the introduction and the executive summary and how to do get these ideas in open discussion and on paper. We have more questions to address, and we would like each of you in your professional roles to provide great feedback from the following questions listed below.

- Q2) What do you believe should be the goal of this task force?
- Q3) What are you responsible for?
- Q4) What are we (Health Disparities Task Force) responsible for?
- Q5) How do you use the information that we're providing you all within your organizations as far as spreading the word?
- Q6) What are we really wanting to do outside of the presentations, outside the great communications that we have with the top ten, the feedback that you all have been giving to us which have been developed into these PSA's, the ones that was shown on the Super Bowl and some upcoming ones in March Madness?
- Q7) What do you see the task force accomplishing annually?
- Q8) Do you think there we should prepare recommendations report every year or every other year? Is that something you want to do?

- Brainstorm or gather ideas to eliminate disparities across the state
