# **Weekly Submission Reminder**

Drug overdose data is to be submitted no later than close of business on Tuesday of each week. Submitted files should contain all nonfatal drug overdose records triggered Sunday through Saturday of the preceding calendar week. If a facility does not have any nonfatal drug overdose records to report, they must submit a "zero submission record" as part of the weekly drug overdose submission process.

Regular weekly submissions are crucial for maintaining a pipeline of information to our partners in the regions and metros across the state who use the data you provide to inform public health practice and intervention. To help with maintaining weekly submissions, TDH suggests working to automate your reporting process, ensuring that multiple people are trained and have access to TDH's SFTP site for submitting DOR weekly submission files. These steps will help to ensure your organizations success in maintaining and submitting their required weekly files.

# **DOR SFTP Clean-up**

The Office of Informatics and Analytics would like to remind you that you are required to clean your organizational folders from the SFTP server. To ensure the Department of Health's SFTP server continues to function optimally, we will be removing all Trading Partner's DOR SFTP server folders by removing archivable information On July 2nd, 2024, at 9 a.m. CST.

During this time, all but the four most recently provided DOR validation files will be archived and removed from your DOR/Out folders. Access to your SFTP server will not be affected during the archival process.
