On October 23, 2020, this meeting was first noticed as an electronic meeting held via WebEx, contingent upon the extension of an executive order by the Governor Bill Lee authorizing electronic means for public meetings.¹ This amended notice is to affirm that a Meeting of the Tennessee Underground Utility Damage Enforcement Board (“Board”) will be held electronically via WebEx at **10:00 a.m. on Wednesday, November 4, 2020.**

The ongoing state of public health emergency declared nationally, and by Tennessee Governor Bill Lee on March 12, 2020, places limitations on public gatherings and meetings in order to prevent the spread of the Coronavirus Disease 2019 (COVID-19). In convening the Board meeting electronically, without a physical quorum, the Board relies on Governor Lee’s Executive Order No. 16, and affirms that such is necessary to conduct the essential business of the agency and to protect the health, safety, and welfare of Tennesseans.

Members of the public may participate by calling into the meeting or by filing written comments with the Board at TPUC.docketroom@tn.gov with the Tennessee Public Utility Commission. The Board Meeting will be held live and will be recorded. The public is invited to join the meeting by:
