TN Investco Entities That Receive Investment Credits Under the Tennessee Small Business Act

Updated November 2020

Qualifications

- Tenn. Code Ann. 67-4-2008 (15)
- Any qualified TN Investco, as defined in Tenn. Code Ann. § 4-28-102, that has received an allocation of investment tax credits under the Tennessee Small Business Investment Company Credit Act, compiled in title 4, chapter 28, and continues to participate in the program established by such act



Registration

■ A TN Investco entity that receives Investment Credits under Tennessee Small Business Act must register with Tennessee Department of Revenue for a Franchise and Excise account

RM1

 Exemption request must be supported with a written statement identifying the type of exemption and certifying that the entity qualifies as a TN Investco entity
