1. Ross/Fowler, P.C.

Complete a long-term student housing modernization program, including the construction of two new housing facilities with approximately 100,000 sf and 350 beds each.

## 1. EOA Architects, LLC

The firm demonstrated extensive residence hall experience, including over 2,100 beds in recent years. Similar projects include four new residence halls for Belmont University and a \$102M residential development (677 beds and a parking garage - completed with associate architect Goody Clancy) at Vanderbilt. The Project Manager has managed all of the firm's student housing projects in the last 15 years. The team's consultants include construction administration (Melvin Gill & Associates), food service and cost estimating. The team's experience working together was the strongest of those submitted with more key team members working on more of the submitted projects. The entire team is located in Nashville.

#### 2. Moody Nolan

Using multiple offices, the firm has completed over 6,500 beds in the last four years. The team includes a Student Housing Design consultant (Mackie Mitchell Architects, Asheville, NC and St. Louis, MO). Moody Nolan submitted three similar projects, while Mackie Mitchell provided two. Similar projects from Mackie Mitchell included a \$71.4m, 1,270 bed, four building residential neighborhood for Coastal Carolina University (Conway, SC). The firm's in-house team includes their Studio Director of Housing (in the Columbus, OH office). Additional consultants include food service (Boston), technology & security (Columbus, OH) and cost consultants (Chicago and Toronto, Canada).

#### 3. Street Dixon Rick Orcutt Winslow

The firm demonstrated substantial in-house student housing experience, including two separate residence hall projects for The University of the South and one each for Juanita College and Vanderbilt. The Commons at Vanderbilt is a five building project, totaling \$74.1m. The team includes cost estimating and elevator consultants. The team has experience working together and experience working on the submitted projects. The entire team is located in Nashville and Brentwood.

The existing frame-supported fabric will be removed and replaced with new 22oz. vinyl coated polyester scrim fabric in comparable colors. One tennis court will be converted to a second basketball/volleyball court.

#### 1. Hurst-Rosche, Inc.
