V. First Reading Items

A. Special Education Programs and Services Rule 0520-01-09-.12, -.18, and -.19 (00:39:31-00:47:56)

Ms. Jennifer Jordan, assistant commissioner of special education and intervention for the Department of Education, presented the item. Vice Chair Darrell Cobbins provided the motion to accept the item on first reading, and Mr. Nate Morrow provided the second. Chair Bob Eby shared positive feedback about special education counseling and guidance in the rule revision, and Ms. Jennifer Jordan concurred. Mr. Nate Morrow asked about communicating change to families, schools, and districts. Ms. Jennifer Jordan referenced recurring meetings with the Directors of Special Education, contracts with Vanderbilt University and The Arc Tennessee, and other strategies. This item was approved by a unanimous voice vote.

E. Professional Assessments for Tennessee Educators Policy **5.105** (01:48:58-01:50:58) Ms. Taylor Reid presented the item. Vice Chair Darrell Cobbins provided the motion to accept the item on final reading, and Mr. Larry Jensen provided the second. This item was approved by a unanimous voice vote.

F. Promotion and Retention Rule 0520-01-03-.16

(01:50:59-02:27:21)

Mr. Jack Powers, assistant commissioner of policy implementation and legislative affairs, presented the item. Vice Chair Darrell Cobbins provided the motion to accept the item on final reading, and Chair Bob Eby provided the second. Ms. Angie Sanders followed up on a question from the previous day's workshop about whether the Ground 1 appeal in the

rule conflicts with the 2023 revisions to the retention law. She said her opinion was that it was in conflict as currently written but it could be revised to be consistent with the law by including additional factors. Chair Bob Eby offered recommendations to revise the rule, including consulting with stakeholders like parents/guardians and school staff. Ms. Krissi McInturff, Mr. Ryan Holt, Mr. Larry Jensen, and Ms. Lillian Hartgrove agreed with the recommendation. Mr. Larry Jensen and Mr. Nate Morrow underscored the importance of prioritizing literacy starting in kindergarten. Vice Chair Darrell Cobbins asked about the fiscal impact of additional tutoring and discussed the importance of stakeholder voice. Commissioner Lizzette Reynolds noted she would check with Department of Education legal on the proposal but agreed that State Board has rulemaking authority. Ms. Angie Sanders noted the district needs to agree to tutoring. Mr. Bob Eby moved to postpone action on the previous motion with the intent that State Board will work with DOE, get input over the next two weeks, and bring back a specific recommendation at the following special called meeting. Chair Bob Eby restated his intent that if there was a pathway to use a 40th percentile state-approved reading screener, it would require 100% agreement with parents, teacher, and other relevant staff members, the school agrees to create an individualized academic remediation program, and the school agrees to provide tutoring. Mr. Wells seconded the motion. The motion was approved by a unanimous voice vote.

G. Promotion and Retention Policy 3.300

(02:27:22-03:09:45)

Dr. David Laird, assistant commissioner of assessment and accountability, presented the item. Chair Bob Eby, Dr. Sara Heyburn Morrison, Mr. Ryan Holt, and Mr. Nate Morrow thanked Dr. David Laird for incorporating feedback. Dr. Sara Heyburn Morrison asked about Tennessee Value-Added Assessment System (TVAAS) calculations and Department of Education business rules, and Ms. Angie Sanders confirmed that is appropriate to remain in Department of Education business rules. Ms. Krissi McInturff shared her perspective as a current teacher. Mr. Ryan Holt provided the motion to accept the item on final reading, and Mr. Warren Wells provided the second. This item was approved by a unanimous voice vote. Mr. Ryan Holt shared his intent to bring two resolutions at the special called meeting in March to reconsider the current 3rd and 4th-grade retention law. Chair Bob Eby shared feedback from an instructional coach concerned about retention. Mr. Nate Morrow underscored that he and others are not opposed to assessments and know they are important to understanding student learning. Vice Chair Darrell Cobbins inquired about evaluating the adequate growth provision, and Dr. David Laird indicated he is open to feedback and evaluation. Ms. Lillian Hartgrove asked about district communication, and Dr. David Laird said they would share business rules, spreadsheets, and other resources. Mr. Ryan Holt and Mr. Nate Morrow discussed the importance of sharing answers with stakeholders in a timely manner versus delaying votes. The vote was approved by a unanimous voice vote.

Mr. Warren Wells made a motion to reconsider Item IV H: Teacher License Discipline Actions: Item H - Mr. Nelson Milsaint. Mr. Jordan Mollenhour provided the second, and there were no objections.

Mr. Warren Wells expressed his concern about the one-year stipulation and its connection to his livelihood. Ms. P. Danielle Nellis provided an overview of the discussion earlier in the meeting. Vice Chair Darrell Cobbins inquired about how the State Board staff reached the one-year stipulation. Ms. P. Danielle Nellis explained the pattern of behavior.

Ms. Taylor Reid explained the various pathways estimated likely at least one semester of full-time classes. Mr. Warren Wells and Mr. Jordan Mollenhour discussed the potential fraudulent behavior. Mr. Warren Wells shared his appreciation for the State Board, and Vice Chair Darrell Cobbins agreed with the new motion. Mr. Warren Wells motioned to remove the one-year stipulation, and Mr. Jordan Mollenhour seconded it.
