#### I. Purpose

In accordance with T.C.A. § 49-6-3001 and State Board of Education ("State Board") Rule Chapter 0520-07-01 and 0520-07-02, the State Board is charged with approving private school accrediting agencies that may recognize Category II and III private schools to operate in Tennessee.

This policy sets forth the list of accrediting agencies approved by the State Board to accredit Category II and III private schools in Tennessee.

#### II. Approved Category II Accrediting Agencies

State Board Rule 0520-07-02-.03 sets forth the process for an accrediting agency to apply for and maintain approval by the State Board as a Category II private school accrediting agency. Approval of Category II accrediting agencies lasts for a period of five (5) years, after which an agency shall re-apply for approval if the agency wishes to continue on the approved list of Category II accrediting agencies.
