Outdated Polices Pertaining to TIBRS Data Collection

Recently, an agency contacted us regarding their agency's policy in the reporting of vandalism offenses/incidents for TIBRS. Their policy states that vandalism is only reported if the value of property is \$100.00 or more. This was based on information obtained from what is now outdated information.

In 2009, we modified the way vandalism is reported for TIBRS. Introduction to Data Collection states "Group A offenses must be reported to TIBRS when the crime is known to law enforcement." Vandalism is a Group A offense, so it should be reported when known to law enforcement, regardless of the amount of property damaged.

Crime in Tennessee Data Verification Procedures

TBI is very appreciative of the hard work agencies demonstrate in keeping their TIBRS data current. The Tennessee program is regarded very highly on a national level and that is due in large part to the work done by the submitting agencies, colleges and universities.

TBI staff currently go through a data review and verification process twice a year of your agencies' data —in July for the first six months of the year and again in January for year end data. We provide a copy of that review to your agencies. We strongly recommend that you conduct your own review on a more frequent basis to ensure that the data TBI releases for your agency and the state is complete and accurate. The review can be done in multiple ways: running a monthly Group A incident list and Group B arrest list and comparing it to your system's data, looking at monthly data levels for both Group A and Group B by running those reports, reviewing the Agency Crime Summary report—also known as the Crime in Tennessee page to name a few. All of these reports are available at www.tncrimeonline.com at the law enforcement site. Even though we officially release data once a year, the statewide data comprised of all your agencies' data is utilized on a monthly basis throughout the year. It is very important that your data entry be current and any errors are corrected in a timely manner.

LEOKA Reporting Clarification from FBI

Law Enforcement Officers who meet the following criteria should be reported as LEOKA victims:

Wear/carry a badge (ordinarily)

Carry a firearm (ordinarily)

Are duly sworn and have full arrest powers

Member of a public governmental law enforcement agency and be paid from government funds set aside specifically for payment to sworn law enforcement

Be acting in an official capacity, whether on or off duty, at the time of incident

Deaths which are directly related to the injuries received during the incident

Exceptions to the above-listed criteria:

Individuals who are killed or assaulted while serving as a law enforcement officer at the request of a law enforcement agency whose officers meet the current collection criteria

Special circumstances will be reviewed by LEOKA staff on a case-by-case basis to determine inclusion Include military and civilian police and law enforcement officers of the Department of Defense (DoD), while performing a law enforcement function/duty, who are not in a combat or deployed (sent outside of the United States for a specific military support role mission) status. This includes DoD police and law enforcement officers who perform policing and criminal investigative functions while stationed (not deployed) on overseas bases, just as if they were based in the United States.

Deaths resulting from the following are <u>not</u> included in the LEOKA program's statistics:

Natural causes such as heart attack, stroke, aneurysm, etc.

On duty but death is attributed to personal situations such as lover's quarrel/triangle, neighbor conflict, etc. Suicide

Following are examples of job positions <u>not</u> included in LEOKA statistics:

Corrections/correctional officers
Bailiffs
Parole/probation officers
Federal judges

Monthly Data Submissions—Vendor Agencies Only

Please remember your monthly agency files are due to TBI no later than the 10th of each month. If possible, please submit the files as close to the first of the month as possible. Earlier submission allows time for possible issues that might prevent your file from successfully processing to be resolved before the monthly deadline. Monthly files should be submitted at the TBI website by following the steps below.

Scroll down to the bottom of the home page under helpful links and click Law Enforcement Resources

Click: TIBRS >TIBRS Monthly Statistical Submission

Please check to ensure the "Agency ORI", "Month to Submit", and "Last Digit of current year" are all correct in the submission page fields. Browse for the file to submit.

The file name should be formatted as follows: ORI.X.year.day of year For example, TN0320100.X.2016.45

The sequential day of year should be the last part of the filename. There should be no extension (.txt, .doc, .csv).

For agencies using TNCOP—TBI staff generate your monthly file on the 1st or 2nd day of each month for the previous month. Any data entered beginning on the first day of the calendar month will not be included in the TBI generated file until the next month. For example if you enter data on April 1st in TnCOP, that data will be included in the file generated on May 1st for the April data entries.
