NOTICE TO DESIGN-BUILDERS REGARDING NOTICE TO ADVERTISE FOR DESIGN BUILD PROJECT

The Construction Division of the Tennessee Department of Transportation (TDOT), an Equal Opportunity Affirmative Action Employer, is seeking to retain the services of Design-Builders for SR- 247 (Beechcroft Road) improvements and SR-396, Saturn Parkway Extension, Maury County, with experience in the following, but is not limited to:

- 1. Bridge Design;
- 2. Interchange and ramp reconstruction under traffic;
- 3. Roadway Design and construction activity integration; and
- 4. Environmental compliance.

Project Description: Project Triple Crown – Project is the extension of State Route 396 (Saturn Parkway) to State Route 247 (Beechcroft Road) on the new alignment. The project will include stream crossing(s) over McCormack Branch (a FEMA Studied Steam), a new grade separated railroad crossing, intersection/interchange modifications to the GM facility and a new connection to SR-247. The approximate mainline length is 1.3 miles. The widening of SR-247 (Beechcroft Road) is to accommodate an eastbound right turn lane onto Town Center Parkway, and will bring improvement to the northwest quadrant of the US 31 (Main Street) and Stephen P. Hirsch Parkway. Furthermore, the widening of SR-247 (Beechcroft Road) is from 2 lanes to 3 lanes with curb & gutter section.
