Regarding Updates to Roadway Design Guidelines Chapter 1

Effective immediately, the following changes apply to the Roadway Design Guidelines Chapter 1.

Regarding FileNet Project Deliverable Sections:

Updated 1-105.00 heading name.

Added in new sections for 1-105.01 Preliminary Field Review, 1-105.02 Public Meeting, and 1-105.03 Site Field Reviews. All Figure and Table numbers have been updated for Chapter 1 due to these additions.

Updated Section 1-105.04 through Section 1-105.06 – Updated Figure 1-4, 1-5, and 1-6 and Table 1-4, 1-5, and 1-6 to reflect other Division's plan sets that may be a part of the project.

Updated Section 1-105.09 Construction FileNet Submittal package to specify that resurfacing submittals do not require a R.O.W. title sheet or checklist.

Regarding Section 1-107.00 Removal of Plans from FileNet:

Updated list to include additional files as shown in the FileNet Submittal Document.

Regarding Section 1-204.08 Chief Engineer and Commissioner Signatures:
