

# Call for Projects - Residual 5303/5304 Funding Fact Sheet (SFY21)

#### **Purpose**

Residual Federal Transit Administration (FTA) Section 5303/5304 Program funding will be awarded to eligible transit planning projects aiming to support ridership, invest in multimodal communities and improve community resilience. Project proposals will focus on planning public-facing transit-related benefits, increasing mobility, and delivering long-term value for Tennesseans.

The funds awarded in this Call for Projects are a distribution of residual funds. Residual funds distributed as part of this Call for Projects will not impact related annual formula allocations of funding. This Call for Projects is not designed as a recurring program.

# **Eligible Projects**

- Strategic Planning
- Comprehensive Operational Analysis
- Systems Planning, Corridor-level Alternatives Analysis, or Network Redesign
- Transit Needs Assessments
- Fare Structure Analysis
- Transit-oriented Development (TOD) Planning
- Coordinated Public Transit Human Services Transportation Planning
- Feasibility Studies for New Transit Service, including Service Plan Development
- Planning and Design for Capital Projects, including:
  - Bus Rapid Transit and Fixed Guideway Stations
  - Transit Centers
  - Mobility Hubs, providing access for various modes of transportation and including curb management delineating how each mode accesses facilities
  - o Transfer Point and Bus Stop Improvements
  - Transit Fueling and Electric Charging Stations
  - Multimodal Infrastructure Improving Access to Facilities, including Bicycle and Pedestrian Improvements
  - Other Strategic Capital and Facility Projects

Residual 5303/5304 funds are not eligible for agency staffing expenses

#### **Available Funds**

**5303:** \$1.0 million in SFY2021

**5304:** \$500,000

### **Minimum Local Match Requirements**

**5303:** Federal – 80%, State – 10%, Local – 10%

**5304:** Federal – 80%, State – 20%

#### **Regulatory Requirements**

Agencies are required to comply with all state and applicable federal procurement rules and requirements.

#### **Project Selection**

Project proposals will be considered for the limited residual funds available. TDOT will consider the following evaluation criteria, geographic distribution, and agency type. Evaluation factors include:

# Transit Ridership and Mobility (0 - 50 points)

Applicants can address this goal with planning projects that aim to provide:

- Improved network design and frequency of service
- Transit priority in the roadway network, such as dedicated transit lanes or traffic signal preemption
- Integration of various transportation modes at transit centers, mobility hubs, transfer centers, and transit stops to improve transit access
- Improvements to the rider experience, such as stop improvements and amenities, real time arrival and bus capacity information, and integrated fare systems
- Long-term planning that allows strategic, targeted, and phased investment in capital and operating projects that will improve mobility for transit riders

# Community Resilience (0 - 25 points)

Projects can address this goal by specifically incorporating:

- Social and environmental justice communities and increasing equity
- Transportation demand management, including strategies for mode shift and vehicle miles traveled reductions
- Transit-oriented development
- Energy efficiency, fuel use reduction and cleaner fuel sources
- Resilience to natural disasters and climate change impacts (flooding, pandemics, heat)
- Other environmental mitigation strategies

#### Local Participation and Coordination (0 - 25 points)

Applicants can address this goal by supporting the application with:

- Letter of support from relevant transit agency (required for 5303 funding)
- Evidence that project that emerged from community comprehensive, transportation or long-range plans
- Evidence that project used or will use equity lens and public involvement to identify needs and develop projects
- Letters of support from community and rider organizations
